Demonstrate compliance with section 7.2.2.3.b.12.Q, regarding “regulations shall apply for fences, light poles or other accessory structures associated with court games” in the plans. Include the cost of estimate under a separate cover or in the letter of intent.

KKAID Response: Setback variance requested considering the fence/light pole is a side yard encroachment.

Add “FINAL SUBMITTAL” to front cover title of plans for heightened clarity.
