Good Afternoon Mr. Seijas,

I have reviewed the City of Miami Beach's memorandum regarding the potential subcontracting of certain permitting functions for major commercial projects to the Miami-Dade County Building Department. I understand that this initiative aims to explore feasibility and the potential benefits of such an arrangement.

While Miami-Dade County has experience managing permitting within the Rapid Transit Zones, this proposal presents several challenges that must be carefully evaluated particularly its impact on coordination between County and City departments, which is essential to maintaining permitting efficiency.

For this initiative to be viable, it is essential to minimize disruptions and unnecessary complexity, ensuring that applicants can efficiently navigate County permitting services. Establishing a process that effectively serves applicants while facilitating seamless interaction with County staff will be critical. This will require the development of clear protocols to streamline communication, uphold service standards, and minimize delays.

Additionally, the financial implications of this initiative remain undetermined and will require further assessment with our Department Director and the County Attorney's Office.

As the Building Official for Miami-Dade County, I am open to discussing this matter in greater detail to better understand the City's objectives and explore potential solutions.
