**Re: ITB 24-238-ND - Pump Station 28 and Force Main Improvements
Recommendation to Award Construction Contract**

Dear Mrs. Ortega:

The Pump Station 28 and Force Main Improvements project was advertised by the City on August 9, 2024. A pre-bid meeting was held August 23, 2024. Four addenda were issued for this project. The bid opening was held on October 18th, 2024, at 3:00 pm. The City received one sole bid for this Invitation to Bid (ITB), from the Poole and Kent Company of Florida (Poole and Kent).


The City provided the bid package for Poole and Kent to Hazen and Sawyer (Hazen) for review. The bid proposal was evaluated considering the sole bidder's compliance with the minimum requirements as stated in the ITB and addenda. Previous experience of the Bidder, Subcontractor, Project Manager, and Superintendent all meet or exceed the minimum requirements outlined in the ITB thus demonstrating the proposed sole bidder's overall technical ability to perform the work. Furthermore, project references were responsive, all of which provided positive feedback and stated they would recommend Poole and Kent for additional work.

Poole and Kent meets the minimum requirements of the ITB and is qualified to perform the work described in the Contract Documents for the Pump Station 28 and Force Main Improvements project. On concurrence of the City's Procurement Department, and City verification that all required licenses, insurances, and bonds are valid and in place, Hazen recommends that the bid submitted by Poole and Kent Florida Company be accepted and the Pump Station 28 and Force Main Improvements project in the amount of \$39,920,000.00 (grand total) be awarded (Reference Bid Tabulation in Attachment A).

We appreciate the opportunity the City has provided us to assist staff with this project and look forward to providing assistance during construction.
