A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, APPROVING THE WAIVER OF THE SPECIAL EVENT APPLICATION FEE IN THE AMOUNT OF \$333 FOR THE ONE-NIGHT POP-UP EVENT “LA POUBELLE ON LINCOLN ROAD,” TO BE HELD ON MAY 30, 2025, AT 430 LINCOLN ROAD, TO ENABLE THE PROMOTERS OF THIS CONCEPT TO TEST THE LINCOLN ROAD MARKET.

WHEREAS, the City of Miami Beach supports activation of Lincoln Road with unique cultural programming that enhances the district’s vibrancy and attracts both residents and visitors to the area; and

WHEREAS, La Poubelle on Lincoln Road is a one-night pop-up event scheduled for Friday, May 30, 2025, at 430 Lincoln Road, featuring a dynamic evening of live jazz, cabaret, and culinary flair, combining professional performances with youth music education with the proceeds of the event to be contributed by the event organizer to the Young Musicians Unite organization; and

WHEREAS, the program will include standout performances by Victor Valdez, Teresa Cesario, Robbie Elias, and Nicole Henry, along with a special set by the Young Musicians Unite Jazz Collective under the direction of Nina Marie, highlighting a commitment to both artistic excellence and community engagement; and

WHEREAS, the event will also offer curated food and cocktails from Silverlake Bistro, with dishes prepared by chef Benoit Rabbot, further contributing to Lincoln Road’s emerging culinary scene; and

WHEREAS, presented in partnership with Young Musicians Unite and supported by civic and cultural organizations, the pop-up exemplifies the type of collaborative, place-based programming that animates public space and fosters a sense of community; and

WHEREAS, the event organizers seek to test the Lincoln Road market with this activation, and the Mayor and City Commission desire to support their effort by waiving the special event application fee in the amount of \$333, in order to help offset start-up costs and encourage further cultural programming on Lincoln Road; and

WHEREAS, the Mayor and City Commission find that supporting this one-night event aligns with the City’s broader objectives to promote cultural vitality, support youth arts education, and stimulate economic and social activity on Lincoln Road.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby approve the waiver of the special event application fee in the amount of \$333 for the one-night pop-up event “La Poubelle on Lincoln Road,” to be held on May 30,

2025, at 430 Lincoln Road, to enable the promoters of this concept to test the Lincoln Road market.
