On November 5, 2024 Miami-Dade County ("County") will be conducting the General Election, at which time the City of Miami Beach has authorized a Special Election to be held, to submit eight ballot questions to the electorate of the City of Miami Beach. Miami-Dade County is charged with the full responsibility of conducting the subject Election, except for accepting Miami-Dade County's Certificate of Election Results concerning the City of Miami Beach's Special Election, which duty is within the Miami Beach City Commission's purview.

The Miami-Dade County Canvassing Board for the County's November 5, 2024 General Election is charged with the statutory responsibilities relating to the conduct of the subject Election and must be authorized to act consistently with said responsibilities as the Canvassing Board for the City of Miami Beach's November 5, 2024 Special Election.

The attached Resolution has thus been prepared to formally authorize the Miami-Dade County Canvassing Board to serve as the Canvassing Board for the City of Miami Beach's November 5, 2024 Special Election.

### **FISCAL IMPACT STATEMENT**

The Miami-Dade County Elections Department has provided the City Clerk with an estimate of approximately \$66,640 to conduct the November 5, 2024 Special Election, which includes the costs associated with 14 days of Early Voting. (See Department of Election Estimates.)
