Located within the Sunset Harbor Mixed-Use Neighborhood Overlay District, Zoned CD-2

Approval History:

PB23-0606, PB20-0344; PB17-0168 (aka PB18-0168): Approved the 5-story mixed-use building with up to $\pm 67,500$ SF, and consisting of up to 24,271 SF of commercial/office space on the ground floor, including 2 restaurants (not to exceed 238 seats total and occupancy content of 199 persons each); parking on the 2nd floor; up to 29,728 SF of commercial/office uses on the 3rd and 4th floors; and up to 2 units on the 5th floor with rooftop amenities

DRB22-0814, DRB20-0549; DRB17-0198: Approved the design of this new 5-story mixed-use office building.

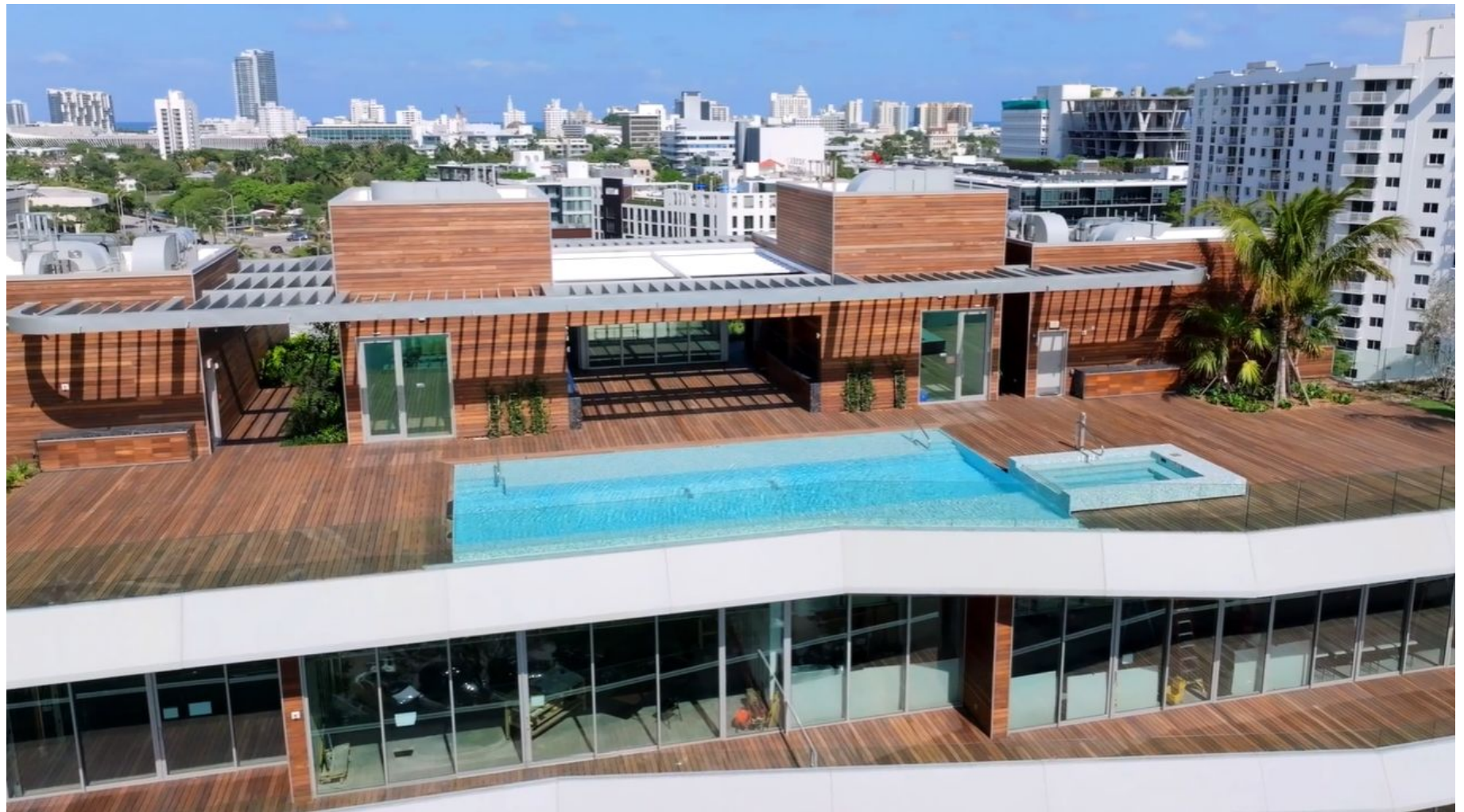
