IV. Approach & Methodology

SFM will source, deliver, and install trees along the city's Beachwalk as per the city's scope of work outlined in section 8 of the quote request.

Site Assessment and Planning:

Our team will conduct a thorough assessment of the Beachwalk area with the City Urban Forester and/or Urban Forestry Division to identify the existing conditions, including soil quality, topography, and presence of invasive species. This information will be used to develop a comprehensive plan that aligns with the city's goals and visions.

- SFM will remove any existing exotic invasive vegetation within the scope of work.
- SFM will mark tree location and species type per location will be marked out visually at the site(s) and verified by the Urban Forestry Division.
- SFM will perform locates for all planting sites.

Plant Selection:

SFM will only select plant material that is Florida Grade No. 1 or better by the latest edition of the State of Florida Grades and Standards Manual for Nursery Plants.

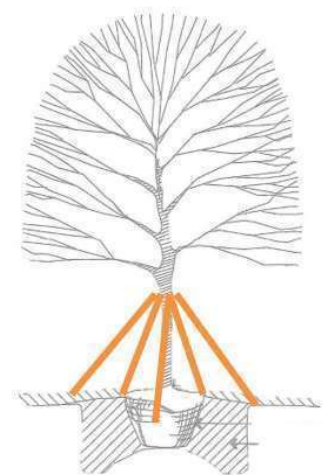
Plant Delivery:

Delivery of plants shall be coordinated with City Representatives and in accordance with the plant installation schedule.

Plant Installation Phases 1 / 2 / 3 / 4 / 5:

SFM Landscape Services will install plants in a systematic manner per City code Sec. 126-6 "Minimum standards", and the dune management practices set forth by the established "Dune Management Plan".

- SFM will use proper MOT in compliance with FDOT.
- Planting sites shall be left clean and all excess soil or other material shall be removed at the end of each workday including old dead vegetation.
- Upon installation, SFM will brace each tree with a minimum of 5 stakes per tree.
- Root barrier shall be installed adjacent to the Beachwalk with a length of x1.5 the canopy spread of trees installed.

Watering Schedule, Maintenance, and Monitoring:

SFM Landscape Services will provide ongoing care and maintenance for the reforestation project for a period of one (1) year after acceptance. This will involve regular inspections, trimming, and weed control to ensure the long-term success of the reforestation effort. SFM will maintain a watering frequency to assure survivability of all tree material for the one-year warranty period.

- At the end of one year after project acceptance, SFM will make a second application of mulch and remove all bracing and straps from trees following the direction of the Urban Forester and/or Urban Forestry Division designees.
- In addition, SFM will perform a one-time structural pruning service for all newly installed trees. This will include the removal of all dead and cross-branching, as well as any codominant branches that may be reduced or subordinated. All pruning cuts shall be in accordance with ANSI-A300 standards.

Maintenance of Traffic MOT

Upon award of this contract, SFM will work closely with the City Urban Forester and/or Urban Forestry Division to conduct a thorough assessment of the designated beach area. This assessment will involve analyzing traffic flow patterns, identifying potential bottlenecks, and determining the most suitable traffic control measures. Based on the assessment findings, SFM will develop a comprehensive Maintenance of Traffic (MOT) plan to assure beachgoers and local traffic are safely rerouted.



Equipment

SFM has 3 full-time mechanics on staff that are responsible for maintenance and upkeep of the fleet and equipment. Equipment is replaced once it has expired its life expectancy. This ensures that services are not interrupted due to equipment breakdown or supply shortages.

SFM utilizes Whip Around, a web-based fleet maintenance software that allows us to track, document, and report vital data we need to optimize the performance of our fleet. Every driver completes a pre-trip inspection daily as a preventative maintenance measure. Whip Around also tracks fuel usage and integrates with our vehicle tracking software, GEOTAB.
