**RECOMMENDATION**

**BACKGROUND/HISTORY**

At my request, on July 29, 2020, the City Commission adopted Resolution No. 2020-31374, authorizing the Miami Beach Police Department (“MBPD”) to proceed with the development of a public safety citizens-on-patrol volunteer program, known as the Civilian Volunteer Patrol (“CVP”) Program. The purpose of the CVP is to improve community policing within our community, by assisting MBPD in patrolling neighborhoods, parks, schools, and commercial areas, specifically within public spaces.

I would like the MBPD to present an update to the City Commission on the implementation of the CVP Program. As part of that update, I would like MBPD to be prepared to address the following:

- Provide an update on recruiting for the program.
- Identify program structure for volunteers, including assigned hours and locations.
- Explore other potential uses for volunteers, perhaps as school crossing guards, at City-permitted special events, etc.
- Issue walkie-talkies or other mobile communication devices, potentially on a separate, dedicated police radio frequency, in which CVP volunteers could report issues directly to MBPD.
