TITLE: DISCUSS A POTENTIAL PARTNERSHIP WITH BEACH BOX FOR THE INSTALLATION OF BEACH BOX KIOSKS AND/OR PORTABLE LOCK BOXES ON THE CITY'S BEACHES.

**RECOMMENDATION**

The Administration recommends discussion of this item and consideration of the benefits and alternatives. If the recommendation of the City Commission is to pursue the expansion of portable lockable devices available for rent on the Beach, then the Administration would recommend preparing a formal competitive solicitation

**BACKGROUND/HISTORY**

On July 24, 2024, at the request of Vice Mayor Laura Dominguez, the Mayor and City Commission approved the dual referral of item C4 N, to the Public Safety and Neighborhood Quality of Life Committee ("PSNQLC") and the Finance and Economic Resiliency Committee ("FERC") to discuss a potential partnership with Beach Box for installation of Beach Box kiosks and/or portable lockboxes on the City's beaches.

**ANALYSIS**

Beach Box Safe Inc., a for-profit corporation, ("Beach Box" or the "Proposer") partners with various hotels on Miami Beach, including the Marseilles Hotel, the Sagamore Hotel and the SLS Hotels to provide portable lockable safes ("Beach Box Safes" or lockboxes) for beachgoers to secure their valuables.

On October 18, 2024, Beach Box presented before the FERC their proposal to provide kiosks and lockboxes on the City's Beach. Each lockbox measures approximately 12" x 8" x 8" and is equipped with security features, including GPS tracking, built-in cameras, and alarm systems. Each kiosk measures approximately 10' x 2' x 6' and is designed to store up to forty (40) lockboxes. While the FERC did not recommend in favor of moving forward with this concept, they did proffer feedback on the proposal originally presented by Beach Box.

Consequently, Beach Box provided a revised proposal, attached hereto as Exhibit A, which was presented for discussion at the December 13, 2024, PSNQLC meeting. The Proposer is planning to install two (2) kiosks at South Beach locations, specifically at the 6th Street restroom, and at the Art Deco Welcome Center on 10th Street, and intended to be affixed to the buildings' walls. Pursuant to their proposal, the standard rental fee of the Beach Box Safes range from \$20 to \$40 per day for patrons with a 20% discount being offered to City residents.

Beach Box is proposing to cover costs associated with the installation, operations, and staffing of its kiosks. They would need to comply with any regulatory approvals required for its implementation, including applicable building permitting and zoning requisites. Given the proposed locations, ensuring the kiosks' installation does not interfere with existing building

lighting, elements, and are not visible from Ocean Drive will also be required. Coordination and installation of electrical additional infrastructure may also be required for the kiosks.

#### Other Considerations

Beach Box could potentially generate some revenue with the installation of its Beach Box Safes and has proposed 10% of revenue towards the City. However, Beach Box should conduct a market study to ascertain or support the potential demand for the use of Beach Box Safes.

Conversely, while Beach Box Safes can be an amenity for beachgoers, lockers and vaults similar to these have been and continue to be provided on the Beach today. For instance, City concessionaire Boucher Brothers, currently provides AquaVaults at a rental rate of \$10 per safe for resort properties and \$6 per safe on the Lummus Park's concession areas. However, these are not in high demand. Beach Box's concept has potential and should be refined further to include a thorough fiscal analysis and additional benefits to the City.

On December 13, 2024, the PSNQLC discussed the Beach Box item. Upon deliberation, the Public Safety and Neighborhood Quality of Life Committee made a favorable recommendation to bring this item before the City Commission for discussion.

## Proposal for Beach Box Installation and Operations

### 1. Product Specifications

#### Beach Box Safes:

- **Dimensions:** Approximately 12" x 8" x 8", weighing under 10 lbs.
- **Key Features:**
  - Secure, lockable safes equipped with GPS tracking, built-in cameras, and alarm systems for heightened security.
  - Integrated phone charger compatible with most smartphones, ensuring beachgoers stay connected throughout the day.
  - Bluetooth speaker with governor and over-the-air volume control, providing a customized beach music experience.
  - Constructed from waterproof and sand-resistant materials for maximum durability in beach environments.
  - Available for rental at convenient kiosks along the beach.
  - Cameras linked to Project Blue Light for real-time security footage, enhancing safety.

#### Kiosks:

- **Dimensions:** Approximately 10' x 2' x 6' (customizable based on city requirements and demand).
- **Key Features:**
  - Each kiosk can accommodate up to 40 Beach Box units, with adjustable capacity to meet demand.
  - Provides ample storage for Beach Box units in both portable and stationary configurations.
  - User-friendly interfaces enable seamless rental and return processes.

- Integrated cameras connected to Project Blue Light for 24/7 security monitoring.
  - Kiosks will feature a clean, streamlined design with no digital displays or advertisements.

## **2. Proposed Kiosk Installations and Locations**

We propose the installation of two kiosks at the following high-traffic, strategic locations along South Beach:

- **6th Street** – Affix to public restroom
- **10th Street** – Affix to the Art Deco Museum.

Though feedback suggests interest in a kiosk for North Beach, we recommend focusing the initial deployment in these areas based on theft statistics provided by the Miami Beach Police Department. Starting with a targeted implementation will help ensure optimal security and operational effectiveness before expanding.

## **3. Cost to the City**

There will be no financial burden on the City of Miami Beach. Beach Box Safe, Inc. will cover all costs related to the installation, operation, and staffing of kiosks. Each kiosk, estimated at \$50,000, will be fully funded by Beach Box Safe, Inc.

---

## **4. Rental Fees, City, and Resident Discounts**

- **Beach Box Rentals:** \$20–\$40 per day, depending on demand and seasonal promotions.

- **City Revenue:** The City will receive 10% of all rental revenue.
  - **Resident Discount:** Miami Beach residents will receive an automatic 20% discount, applied at checkout through a residency verification process using the credit card's zip code.

## 5. Permitting Requirements

Beach Box Safe, Inc. will obtain the following permits from the City of Miami Beach:

- **Building Permit:** For kiosk installation on public land (right-of-way approval).
- **Zoning Compliance:** Ensuring kiosks meet size, design, and safety standards in line with city regulations, including review by the Historic Preservation Board and Design Review Board.
- **Electrical Permits:** Coordination with Florida Power & Light (FPL) for power needs, including central screens, charging stations, credit card processing, and other kiosk functionalities.




