**RECOMMENDATION**

Please place on the February 3, 2025, City Commission agenda a referral to the Public Safety and Neighborhood Quality of Life Committee to discuss the development of a comprehensive long-term public safety plan and potential funding needs for the Baywalk. Once complete, the Baywalk will attract additional residents and visitors, making it essential that it remains a safe, welcoming environment for all.

As part of this referral, the Administration should be prepared to discuss strategies for crime prevention, emergency response protocols, lighting, surveillance, and other safety measures. This should include the installation of gates to regulate access between the new 5th street pedestrian bridge and the baywalk, as well as establishing defined hours of operation for the bridge to ensure its safety during non-operational hours. In addition, the plan should include the development and implementation of an on-going police detail for the Baywalk. This plan should create an environment that promotes safety and peace of mind for both residents and visitors.
