Please place the above item on the February 3, 2025 City Commission meeting agenda as a referral to the Land Use and Sustainability Committee ("LUSC").

Currently, two (2) story single-family homes that exceed 60 feet in length have additional open space requirements, in excess of the minimum required side yard. The purpose of this additional open space is to add movement to long expanses of uninterrupted two-story volumes at or near the required side yard setback line.

I would like the LUSC to consider whether the Land Development Regulations of the City Code (LDR's) should be amended to simplify these open space regulations, including the location, elevation and dimensions of the space. As part of this discussion, I am also requesting that the Planning Department present recommended modifications to the applicable sections of the LDR's.
