WHEREAS, the City Commission desires to prioritize these improvements to support the well-being of Miami Beach residents and visitors who rely on this public facility; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby direct the Administration to focus on improving cleanliness at the 17th Street Parking Garage (G5), with a particular emphasis on high-traffic areas, such as the stairwells and elevators.


