Ad Hoc City Lighting Plan Advisory Committee

Composition:

A. Purpose

- 1. The purpose of the Ad Hoc City Lighting Plan Advisory Committee (the "Committee") is to review existing lighting infrastructure, identify areas for improvement, and make recommendations to the City regarding a comprehensive lighting plan for the City of Miami Beach that addresses safety, aesthetics, functionality and energy efficiency of lighting in public spaces, rights of way and commercial and residential areas for the benefit of residents and visitors.
- 2. The Committee considers functional aspects, such as visibility and security, as well as aesthetic elements like ambiance and architectural lighting.
- 3. The Committee shall make recommendations regarding the following elements that would be addressed in a Comprehensive Lighting Plan:
 - a. Safety and Security (Street Lighting and Public Spaces).
 - b. Environmental Impact.
 - c. Architectural Lighting for Landmarks, Public Buildings and Monuments.
 - d. Energy Efficiency.
 - e. Lighting Design Guidelines for Commercial and Residential Structures.
 - f. Such other matters as the Mayor and City Commission shall determine by Referral to the Committee.
- 4. The Committee will meet on a monthly basis, or as frequently as the Committee deems necessary to make final recommendations. The Committee will sunset at the end of one (1) year unless determined by the Mayor and City Commission that it should be extended.

B. Membership Composition

- 1. The Committee shall be composed of seven (7) at-large appointments made by the Mayor and City Commission as a body.
 - 2. Minimum membership criteria for the Committee: individuals must be residents of the City for a minimum of two (2) years, or demonstrate ownership/interest in, or employment relationship with a business established in the City for a minimum of two (2) years. Exceptions to the foregoing may be approved by a majority vote of the City Commission for the electrical engineer member.
 - 3. The composition of the Committee shall be as follows:
 - a. Resident Members.
 - i. At least two (2) of the seven members must currently reside within the North Beach area, generally considered as that portion of Miami Beach located north of 63rd Street.
 - ii. At least two (2) of the seven members must currently reside within Mid Beach area, generally considered as that portion of Miami Beach located south of 63rd Street and north of 23rd Street.
 - iii. At least two (2) of the seven members must currently reside within the South Beach area, generally considered as that portion of Miami Beach located south of 23rd Street.
 - b. Technical Member. At least one (1) of the seven members must be an electrical engineer, preferably with expertise in urban lighting.
 - 4. The Mayor and City Commission will consider the following additional criteria when making appointments:
 - a. Applicable knowledge and experience relevant to the Committee's purpose.
 - b. Past and present community service, especially leadership roles and experience on other advisory committees or boards.

Composition:

A. Purpose

1. The purpose of the Ad Hoc City Sanitation Advisory Committee (the "Committee") is to make recommendations regarding areas for improvement; identification of efficiencies, state-of-the-art technology and other tools for maintenance of sanitation services; and community outreach for improving behaviors to improve the cleanliness and sanitation of the City of Miami Beach.
2. The Committee shall make recommendations regarding the following areas where innovation may be beneficial to the City:
- a. streets.
 - b. parks.
 - c. beaches.
 - d. parking lots.
 - e. waterways.
 - f. sidewalks.
3. The Committee shall make recommendations regarding the following problem issues where innovation may be beneficial to the City:
- a. dirt.
 - b. litter.
 - c. garbage cans/ dumpsters.
 - d. organic material.
 - e. and fecal matter.
4. Additionally, the Committee may consider and make any other recommendations to the City that are consistent with its mission of improving cleanliness and sanitation in our City.
5. The Committee will meet on a monthly basis, or as frequently as the Committee deems necessary to make final recommendations. The Committee will sunset at the end of one (1) year unless determined by the Mayor and City Commission that it should be extended.

B. Membership Composition

1. The Committee shall be composed of seven (7) at-large appointments made by the Mayor and the City Commission.
2. The seven (7) appointments shall, to the extent that willing committee members can be identified from each area, be selected as follows: two (2) members each from the South Beach, Mid-Beach, and North Beach areas and one (1) additional member from the City as a whole.
3. Membership criteria for the Committee: individuals must be residents of the City for a minimum of one (1) year, or demonstrate ownership/interest in, or employment relationship with, a business established in the City for a minimum of one (1) year.

Resolution 2024-33048 re-established the "Ad Hoc Iguana Remediation Advisory Committee," for a period of one year (subject to earlier or later sunset by the City Commission), to study what actions other jurisdictions have taken to address iguana invasions and making recommendations to the Mayor and City Commission regarding iguana mitigation and removal options.

A. Purpose

- 1. On June 28, 2023, Resolution No. 2023-32650 re-established the Ad Hoc Iguana Remediation Advisory Committee for a period of one year (subject to earlier or later sunset by the City Commission), to study what actions other jurisdictions have taken to address iguana invasions and making recommendations to the Mayor and City Commission regarding iguana mitigation removal options.
- 2. The Committee will meet on a monthly basis, or as frequently as the Committee deems necessary to make final recommendations. The Committee will sunset on June 28, 2024, unless determined by the Mayor and City Commission that it should be extended.

B. Membership Composition

- 1. The Committee shall be composed of seven (7) direct appointments made by individual City Commissioners and the Mayor.
- 2. Membership criteria for the Committee: individuals must be residents of the City for a minimum of two (2) years, or demonstrate ownership/interest in, or employment relationship with a business established in the City for a minimum of two (2) years. Exceptions to the foregoing may be approved by a majority vote of the City Commission for individuals with specific knowledge or expertise relative to iguana remediation or other invasive nonnative species remediation.

C. Powers and duties

The Committee will serve to study actions taken by other jurisdictions to prevent, eradicate, and control the spread of invasive iguanas and advise the City Manager and the City Commission on potential actions available to the City in addition to contracting with an iguana mitigation and removal services, including, without limitation, recommendations regarding the Administration's competitive solicitation for iguana mitigation providers.

D. Conflict of interest.

In accordance with Florida law, under circumstances presenting a conflict of interest, an advisory board member should abstain from voting with respect to any measure in which the advisory board member has a personal, private, or professional interest and which inures to his special private gain or the special gain of a principal by whom he is retained. The City Attorney's Office liaison shall assist advisory board members in addressing any potential voting conflicts, as necessary.

E. Administrative Liaison

The supporting departments for the Committee shall be the City Manager's Office, and the Public Works Department. The City Attorney's Office shall provide counsel to the Committee.

A quorum shall consist of three (3) or more members.

Composition:

A. Purpose

The Nightlife Industry Taskforce ("NITE") will serve to advise the City Manager on nightlife issues and to provide a forum to address quality of life issues affecting our residents, as a result of the City's popularity. The NITE will endeavor to continue and enhance communication and cooperation between the Nightlife Industry and the Administration. The purpose of this Task Force is to provide more specific details regarding trends impacting the industry and creating a mechanism to quickly and proactively address issues in an effort to keep the public updated on event planning.

B. Membership Composition

1. The Task Force shall be composed of seven members, with seven (7) direct appointments made by individual city commissioners and the mayor, all of whom shall be appointed to serve for a term of no more than one (1) year at a time. At least three (3) members must be representatives from nightclubs, restaurant or entertainment establishments, or the hotel industry.
2. Membership criteria for the NITE: individuals must be residents of the city for a minimum of two (2) years, or demonstrate ownership/interest in, or employment relationship with, a business established in the city for a minimum of two (2) years. Exceptions to the foregoing may be approved, by a majority vote of the City Commission for individuals with specific knowledge or expertise relative to the nightlife Industry.

C. Powers and duties

The NITE's powers and duties are as follows:

- a. To serve in an advisory capacity to the City Manager with respect to matters pertaining to the nightlife industries and businesses in the City, and its impact on the quality of life of our City.
- b. To advise the City of nightlife industry trends and events that may require an increase or adjustment in the level of City services.
- c. To make recommendations as to the needs and concerns of the public and the nightlife industries and businesses in the City, including how those needs can best be met.
- d. To advise on methods of promoting the safe growth and stability of nightlife industries and businesses in the City.
- e. To focus on and make recommendations regarding targeted marketing initiatives.
- f. Review and make recommendations regarding the City's MEP. Review and make recommendations regarding the laws affecting the nightlife industry.

Composition:

A. Purpose

1. To provide informed input and recommendations on the activation and utilization of the South Shore Community Center, as well as the enhancement of the 6th Street corridor. This includes ensuring that these spaces are effectively integrated to serve the community while preserving their unique character, improving safety, and enhancing the overall quality of life for residents and visitors along the 6th Street corridor.
2. The Committee will meet on a monthly basis preferably at the South Shore Community Center. The Committee will sunset in twelve (12) months unless determined by the Mayor and City Commission that it should be extended.
3. The Committee will offer feedback on programming ideas, including a calendar of activities and other initiatives aimed at enhancing the overall quality of life of residents and visitors while maintaining the unique character of the South Shore Community Center and the 6 Street Corridor. The committee's input would be critical in transforming the South Shore Community Center and the 6th Street corridor into vibrant, safe, and inclusive community spaces that reflect the spirit and identity of the area.

B. Membership Composition

1. The Committee shall be composed of nine members, with seven (7) direct appointments made by individual city commissioners and the mayor, all of whom shall be appointed to serve for a term of no more than one (1) year at a time.
2. Membership criteria: individuals must be residents of the city for a minimum of two (2) years, or demonstrate ownership/interest in, or employment relationship with, a business established in the city for a minimum of two (2) years.
- a. All voting members must be residents or local business owners with residencies or businesses within the area north of 5th Street and south of 11th Street, between Alton Road and Washington Avenue.
- c. There shall be one nonvoting, ex officio representative from the Rainbow Intergenerational Daycare Center, and one nonvoting, ex officio representative from the Lulav Square Apartments.
- d. Exceptions to the membership criteria may be approved, by a majority vote of the City Commission for individuals with relevant knowledge or expertise relative to the South Shore Community Center and the 6 Street Corridor.

Affordable Housing Advisory Committee

Composition:

The Affordable Housing Advisory Committee shall consist of 11 voting members, each of whom shall have a two-year term. One member of the committee shall be the mayor or a member of the city commission, appointed at-large by a majority vote of the mayor and city commission. The remaining 10 members shall be appointed at-large by a majority vote of the mayor and city commission and must include members from at least six (6) of the following categories:

- 1. One citizen actively engaged in the residential home building industry in connection with affordable housing;
- 2. One citizen actively engaged in the banking or mortgage banking industry in connection with affordable housing;
- 3. One citizen who is a representative of those areas of labor actively engaged in home building in connection with affordable housing;
- 4. One citizen actively engaged as an advocate for low-income persons in connection with affordable housing;
- 5. One citizen actively engaged as a for-profit provider of affordable housing;
- 6. One citizen actively engaged as a not-for-profit provider of affordable housing;
- 7. One citizen actively engaged as a real estate professional in connection with affordable housing;
- 8. One citizen who actively serves on the local planning agency pursuant to Florida Statute §163.3174 (Planning Board member);
- 9. One citizen who resides within the jurisdiction of the local governing body making the appointments;
- 10. One citizen who represents employers within the jurisdiction;
- 11. One citizen who represents essential services personnel, as defined in the local housing assistance plan.

If the City, due to the presence of a conflict of interest by prospective appointees, or other reasonable factor, is unable to appoint a citizen actively engaged in these activities in connection with affordable housing, a citizen engaged in the activity without regard to affordable housing may be appointed.

Composition:

- The Black Affairs Advisory Committee shall have the following powers and duties:
- (a) Serve in an advisory capacity to the City Manager and the Mayor and City Commission concerning issues and programs affecting the City's Black residents, businesses and visitors;
 - (b) Foster increased involvement by the City's Black community in the affairs of City government;

In filling any vacancy, the Mayor and City Commission may select a replacement committee member from a list of three candidates which shall be submitted by the remaining members of the committee. The individual members of the City Commission may supplement the committee's suggested list with additional names of candidates or, if neither the candidates on the committee's suggested list nor the additional names submitted by the individual members of the City Commission are approved, the committee shall submit an entirely different list for the Mayor and City Commission's Consideration. This process shall continue until a suitable replacement has been found to fill the existing or anticipated vacancy. The suggested list submitted by the committee for the Mayor and City Commission's consideration shall be submitted without specific recommendations or endorsements by the committee as to any particular name submitted therein, but may, in the event the name of a current committee member is submitted for reappointment, indicate, as a point of information to the Mayor and City Commission, that said name is that of an existing committee member.

RSA Art. I Sec. 2 118-131 Reso 2022-32165 / 2024-4649 & 4650

Composition:

The Board of Adjustment shall have the following powers and duties:

- (1) To hear and decide appeals pursuant to the procedural requirements of Section 118-9.
- (2) To authorize, upon application, such variance from the terms of these land development regulations where authorized by section 118-351(a), pursuant to the requirements of chapter 118, article VIII, of the land development regulations, as will not be contrary to the public interest when, owing to special conditions, a literal enforcement of a provision of these land development regulations would result in unnecessary and undue hardship. Five affirmative votes shall be necessary to approve any variance request.

The Board of Adjustment shall serve as the city's floodplain management board in reviewing applications for properties within its jurisdiction and shall have the authority to exercise all powers and perform all duties assigned to such board pursuant to section 54-31 et seq. and Resolution No. 93-20698, and in accordance with the procedures set forth therein as such ordinance and resolution may be amended from time to time. For the purposes of determining jurisdiction, the criteria in section 118-351(a) shall be utilized.

The Board of Adjustment shall consist of seven voting members.
Members shall be appointed for a two-year term, by a five-sevenths vote of the City Commission.

Two members shall be appointed as citizens at-large, and five professional members shall each be appointed as follows: A) One member shall be an architect registered in the State of Florida, or a professional practicing in the field of architecture or landscape architecture, and the remaining four members shall represent one of the following professions (no more than one member per profession) namely: 1) law, 2) engineering, 3) real estate development, 4) certified public accounting, 5) financial consultation, and 6) general business.
The members representing the professions of architecture, law, engineering, and public accounting shall be duly licensed by the State of Florida; the member representing general business shall be of responsible standing in the community, the member representing the field of financial consultation shall be a certified public accountant, chartered financial analyst, certified financial planner, a chartered financial consultant or investment advisor registered with the Securities and Exchange Commission, or someone recognized as having similar credentials and duly licensed by the State of Florida.

Members of the board of adjustment must either be residents or have their principal place of business in Miami Beach.

Each voting member of the board shall be required to complete an architectural walking tour offered by the Miami Design Preservation League (MDPL), which includes the National Register Architectural District in South Beach and an historic district in North Beach. In the event tours offered by MDPL are no longer available, this requirement may be satisfied by completing a similar architectural tour conducted by an educational or nonprofit organization as may be approved by resolution of the city commission. Members shall use their reasonable best efforts to complete the tour within sixty (60) days of their initial appointment.

- (8) A representative selected by the Parent Teacher Association of Treasure Island Elementary School.
- (9) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Rabbi Alexander Gross High School & Hebrew Academy.
- (10) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Yeshiva Elementary School.
- (11) A representative selected by the Parent Teacher Association, or an equivalent parental organization of St. Patrick Catholic School.
- (12) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Casa Dei Bambini.
- (13) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Lehrman Community Day School Inc.
- (14) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Klurman Mesivta.
- (15) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Temple Beth Sholom Innovation School.
- (16) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Mater Beach Academy.
- (17) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Montessori Academy at St. Johns.
- (18) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Le Petite Papillon Montessori.
- (19) A representative selected by the Parent Teacher Association, or an equivalent parental organization of Mechina of South Florida (the Mesivta of Greater Miami).
- (20) Seven members of the public with knowledge or expertise with regard to education issues who shall be direct appointments by the mayor and each city commissioner with no more than three who can be employed or contracted by Miami-Dade County public schools.

A quorum shall consist of nine (9) members. All voting members must be parents/guardians of students attending a Miami Beach school who are also City of Miami Beach residents; provided, however, that the city commission may waive this requirement on a four-sevenths vote for any applicant who is not a parent/legal guardian of a student attending a Miami Beach school, but otherwise meets the city affiliation requirement in section 2-22 of the city code. The city commission shall designate two of its members to serve as city commission liaisons who shall report to the city commission actions of the committee for quality education; the city manager shall further designate a member of city staff to serve as a liaison who shall report the committee's actions to the city manager.

Composition:

(a) The Design Review Board shall be composed of seven regular voting members. Each regular member shall be appointed with the concurrence of at least four members of the city commission. One person appointed by the city manager from an eligibility list provided by the disability access committee shall serve in an advisory capacity with no voting authority. The planning director or designee, and city attorney or designee, shall serve in an advisory capacity.

(b) The Design Review Board shall consist of the following seven regular members:

1. One architect registered in the United States or a professional practicing in the field of architecture or architectural design.
2. An architect registered in the State of Florida or a member of the faculty of the school of architecture, urban planning, or urban design in the State, with practical or academic expertise in the field of design, planning, historic preservation or the history of architecture, or a professional practicing in the fields of architectural design, or urban planning;
3. One landscape architect registered in the State of Florida or a professional practicing in the field of landscape architecture.
4. One architect registered in the United States, or a professional practicing in the fields of architectural or urban design, or urban planning, or a resident with demonstrated interest or background in design issues; or an attorney in good standing licensed to practice law within the United States;
5. Two persons who are residents at-large and who currently reside in the city and have resided in the city for at least (3) three consecutive years at the time of appointment or reappointment. Additionally, strong preference shall be given to individuals who have previously served on a Miami Beach board or committee and/or completed the Miami Beach Leadership Academy course, and to individuals not currently working in the fields of real estate development, real estate brokerage/sales, real estate law, or architecture; and
6. (a) A licensed professional engineer, licensed professional architect, or licensed professional landscape architect with expertise in water resources; (b) a person licensed by the State of Florida in hydrology, water or wastewater treatment; (c) a person with a degree from an accredited college or university in a field of study related to water resources; (d) a floodplain manager or a principal community administrator responsible for the daily implementation of flood loss reduction activities including enforcing a community's flood damage prevention ordinance, updating flood maps, plans, and policies of the community, and any of the activities related to administration of the National Flood Insurance Program (NFIP) (a "water management expert"); or (e) a person who is a resident at-large and currently resides in the city and has resided in the city for at least three consecutive years at the time of appointment or reappointment.

(c) Eligibility. An eligibility list for these professional membership categories may include, but shall not be limited to, suggestions from the following professional and civic associations as listed below:

- (1) American Institute of Architects, local chapter.
- (2) American Society of Landscape Architects, local chapter.
- (3) The Miami Design Alliance.
- (4) American Planning Association, local chapter.
- (5) The Miami Design Preservation League and Dade Heritage Trust.
- (6) Other city civic, neighborhood and property owner associations.

(d) Residency and or place of business. All regular members shall reside in or have their primary place of business in the county, except for the water management expert appointed pursuant to subsection (a)(6), who need not reside in or have a principal place of business in the county, and except as otherwise provided in subsection (a)(5). The two resident at-large members and one of the registered landscape architects, registered architects, or professionals practicing in the fields of architectural or urban design or urban planning shall be residents of the city.

(e) Each voting member of the board shall be required to complete an architectural walking tour offered by the Miami Design Preservation League (MDPL), which includes the National Register Architectural District in South Beach and an historic district in North Beach. In the event tours offered by MDPL are no longer available, this requirement may be satisfied by completing a similar architectural tour conducted by an educational or nonprofit organization as may be approved by resolution of the city commission. Members shall use their reasonable best efforts to complete the tour within sixty (60) days of their initial appointment.

Composition:

The purpose of the General Obligation Bond Oversight Committee is to make advisory recommendations to the City Manager and the City Commission from a macro perspective regarding the timely progress, overall goals, costs, including financial efficiencies, and the timely completion of General Obligation Bond Program ("G.O. Bond Program") projects approved by the voters in the City of Miami Beach Special Elections held on November 6, 2018 and November 8, 2022.

The General Obligation Bond Oversight Committee shall be composed of fourteen (14) members as follows:

Eight (8) at-large, voting members, with staggered terms, appointed by the City Commission as follows:

- (1) two City residents from the North Beach area;
- (2) two City residents from the Mid-Beach area; and
- (3) two City residents from the South Beach area.
- (4) two City residents from any geographic area of the City with experience working with cultural/arts organizations, including with respect to operations, facilities management or design.

One direct appointment by the Mayor who shall be a voting member and a resident of any area of the City, and who shall serve as chair of the Committee.

Five (5) ex-officio, non-voting members as follows:

- (1) a designee of the City's Audit Committee;
- (2) a designee of the City's Parks and Recreational Facilities Board;
- (3) a designee of the City's Budget Advisory Committee; and
- (4) a designee of the City's Sustainability Committee.
- (5) a designee of the City's Cultural Arts Council.

The voting members shall serve two-year terms.

- (1) The term limits for the voting members set forth in subsection (a)(1)-(3) shall be governed by the term limits set forth in Section 2-22(5)(b) of the City Code for at-large appointees.
- (2) The term limits for the chair of the Committee shall be governed by the term limits set forth in Section 2-22 (5)(a) of the City Code for direct appointees.

Each of the nine (9) voting members must demonstrate a high degree of knowledge or expertise in one or more of the following areas or disciplines:

- (1) Banking/Finance;
- (2) Construction;
- (3) Real Estate Development;
- (4) Construction Management;
- (5) Recreational or Cultural/Arts Operations, Facilities Management/Design;
- (6) Architecture;
- (7) Landscape Design/Landscape Architecture;
- (8) Public Safety/Security Systems;
- (9) Public Works;
- (10) Public Facilities;
- (11) Engineering;
- (12) Urban Planning/Design;
- (12) Resiliency/Environmental Management;
- (14) Communications; or
- (15) Neighborhood Leadership.

The main supporting departments for the General Obligation Bond Oversight Committee shall be the City Manager's Office, the Finance Department, the Capital Improvements Projects Department, and the Facilities & Fleet Department. The City Attorney's Office shall provide counsel to the Committee and the City's Office of the Inspector General shall provide oversight.

(a) A licensed professional engineer, licensed professional architect, or licensed professional landscape architect with expertise in water resources; (b) a person licensed by the State of Florida in hydrology, water or wastewater treatment; (c) a person with a degree from an accredited college or university in a field of study related to water resources; (d) a floodplain manager or a principal community administrator responsible for the daily implementation of flood loss reduction activities including enforcing a community's flood damage prevention ordinance, updating flood maps, plans, and policies of the community, and any of the activities related to administration of the National Flood Insurance Program (NFIP) (a "water management expert"), each of the foregoing with professional experience and demonstrated interest in historic preservation; or (e) a person who is a resident at-large and currently resides in the city and has resided in the city for at least three consecutive years at the time of appointment or reappointment.
- 6. A member of the faculty of a school of architecture in the State of Florida, with academic expertise in the field of design and historic preservation or the history of architecture, with a preference for an individual with practical experience in architecture and the preservation of historic structures.

(b) All members of the Board except the architect, university faculty member, and water management expert shall be residents of the City; provided, however, that the City Commission may waive the residency requirement (if applicable) by a 5/7th vote, in the event a person not meeting the residency requirement is available to serve on the Board and is exceptionally qualified by training and/or experience in historic preservation matters. All appointments shall be made on the basis of civic pride, integrity, experience and interest in the field of historic preservation.

The committee shall make advisory recommendations to the city commission and the city manager on initiatives to be implemented and supported by the city regarding a variety of issues to ensure the well-being and quality of life of the Miami Beach LGBTQIA+ Community. The committee shall annually compile and submit, in a timely manner, with the assistance of the staff liaison, city data and information to be scored by the human rights campaign's ("HRC") municipal equality index ("MEI") on the city's non- discrimination laws, policies, and services. Marine and Waterfront Protection Authority

Sec. 2-190.46 / 2024-4612 /

Composition:

Composition:

The Marine and Waterfront Protection Authority shall consist of fourteen (14) voting members, who shall be direct appointments with the Mayor and City Commissioners, each having two (2) direct appointments.

Appointments to the Authority shall consist of a combination of individuals who have had previous experience in:

1. The operation or inspection of marine facilities, including experience in various types of marine vessels and boating activities; and/or
2. Who have an interest in preservation of the City's beaches and waterfronts.

The members of the Authority shall have the right and duty to consult with any member of the City Administration for technical or other information pertaining to the matters before them.

Powers and duties:

- (1) Make periodic reports and advisory non-binding recommendations to the city manager or the city commission for the improvement of standards for the city in marine-related matters to promote and maintain a safe clean and healthy marine environment to be enjoyed by the city's residents and visitors. This shall include working in cooperation with federal, state, and local agencies interested in marine standards and clean and clear waterways; and to publicizing the importance of adequate standards; and holding and conducting public hearings, discussions, forums and institutes to arrange programs for the presentation of information by experts in related fields.
- (2) Foster and maintain a clean, litter-free marine environment by exploring the availability of enforcement techniques, new ordinances, and the active promotion of voluntary cleanups.
- (3) Make recommendations regarding any ongoing and future waterside activities including the permitting and policing of water-related and beach concessions, wateroriented and marine-related special events, and marine and waterfront environmental issues.
- (4) Make recommendations to the city manager and the city commission regarding potential suspension or revocation of business tax receipts for commercial charter operators that engage in nuisance or habitual unlawful activities. The City Manager shall respond to any recommendation made pursuant to this subsection within 30 days.
- (5) The investigation, development, and carrying out of plans for the preservation and renourishment of the beaches in the city, including, but not limited to, erosion control.
- (6) To foster and maintain a clean, safe, and litter-free beach environment by exploring the availability of enforcement techniques, programs, or new legislation to accomplish these goals.
- (7) The encouragement of a desire in the citizenry and visitors to the city to maintain and preserve the city's beaches.
- (8) The recommendation of plans to the city manager, city commission, as well as to other local, state, and federal governmental agencies, for the preservation and nourishment of the city's beaches.
- (9) The authority's power of review and recommendation set forth hereinabove shall apply as well to such matters concerning maintenance of city boardwalks, beach walks, cutwalk and baywalks.

Miami Beach Commission For Women

Composition:

Purpose.
The purpose of the commission is to support continuing efforts for economic, political and social equality of opportunity for all women, with special emphasis on the needs of women in the city and to serve in an advisory capacity to the city commission and the city administration.

Powers and duties.
The commission shall have the following duties, functions, powers and responsibilities:

- (1) To serve in an advisory capacity to the city commission, the city administration, the community and all agencies and persons in the city in respect to all matters pertaining to the status of women, including, but not limited to, discrimination against women, greater representation for women in all areas of city government, i.e., boards and committees, employment of women, education of women and attitudes towards women in the community, and to make periodic reports and recommendations to these bodies in respect to such matters.
- (2) To make a continuing study of all existing city institutions, facilities and services, and programs dealing with women or affecting women, and consider the future needs of this area in respect to such institutions, facilities, services and programs.
- (3) To serve as liaison between the city commission and the city administration, and consult with representatives of such bodies from time to time as requested and necessary in order to carry out the commission's duties and functions.
- (4) To make studies and have studies made of the problems of discrimination against women employees, increasing the availability of part time employment for women, and attributable changes towards women in the community, and to formulate and recommend plans and programs for the coordination of the activities of all governmental entities and nongovernmental agencies dealing with these problems.
- (5) It is the express purpose of this commission to serve as a medium for responsible persons to utilize and consult with in attempting to understand and solve the many complex problems involved with dealing with the status of women, and to make findings and recommendations to the city commission and the city administration regarding such matters as are presented to the commission.
- (6) To perform such other duties as may from time to time be assigned to it by resolution of the city commission.

- (4) Provide a forum for the Committee to share best practices and lessons learned from completed projects and/or ongoing projects, for potential incorporation as part of future projects.

Composition
The committee shall be composed of seven (7) members. all of whom shall be appointed to serve for a term of no more than two (2) years at a time. Each member of the city commission shall make one (1) direct appointment to the committee.

- (1) The seven (7) members shall be affiliated with the city pursuant to the general requirements in section 2-22 of the City Code. In addition. the members must meet the following requirements:
- (2) General Requirements. Each of the seven (7) members must have a demonstrated interest in flood mitigation, sea level rise and adaptation, infrastructure, and/or neighborhood leadership issues, including, without limitation, academia, homeowners associations, condominium associations, cooperatives. civic groups, or other similar qualifications. It would be beneficial if members have expertise in the following fields:

- a) Civil engineering or related background with a focus on infrastructure
- b) Architecture. landscape architecture, or related field with a focus on neighborhood planning
- c) Public engagement or communications for construction or neighborhood planning or similar
- d) Emergency management planning, or disaster or flood mitigation.

The purpose of the North Beach CRA Advisory Committee is to make advisory recommendations to the Administration and the City Commission regarding the North Beach CRA.

Composition; knowledge and experience:

The Committee shall be composed of seven (7) at-large appointments, all of whom shall be appointed to serve for a term of no more than two (2) years at a time. There shall also be one (1) nonvoting, ex-officio representative of the Normandy Fountain Business Association, who shall not count toward a quorum for the Committee.

The seven (7) members shall be affiliated with the City in the following ways:

(1) Resident Members.

- a. At least one (1) of the seven members must currently reside for a minimum of five (5) years within the North Beach area generally considered as that portion of Miami Beach located north of 63rd Street.
- b. At least three (3) of the seven members must currently reside. for a minimum of five (5) years within the geographic boundaries of the North Beach CRA or within a 300-foot radius thereof.
- c. The five (5) year minimum residency requirement in subsections (1)(a) and (1)(b) may be waived upon a 5/7ths vote of the city commission, in the event a resident within the applicable geographic area is available to serve on the committee and is exceptionally qualified by training and/or experience.
- d. The 300-foot radius residency requirement in subsections (1)(b) may be waived upon a 5/7ths vote of the city commission, in the event a resident within a reasonable distance from the 300-foot radius of the North Beach CRA geographic boundary and is exceptionally qualified by training and/or experience.

(2) Business Member. At least one (1) of the seven members must demonstrate an Ownership Interest for a minimum of five (5) years in a Business established within the geographic boundaries of the North Beach CRA, without regard to that person's residency. A candidate who satisfies requirements as both a Resident and Business Owner may qualify for either the Resident Member category or the Business Member category pursuant to this subsection.

(3) Real Estate Industry Member. At least one (1) of the seven members of the Committee must be a real estate industry professional, residing generally within the City of Miami Beach.

(4) Attorney Member. At least one (1) of the seven members of the Committee must be an attorney with experience in land use, real estate, or other related practice area, residing generally within the City of Miami Beach or maintaining a full-time law practice and physical office located in North Beach.

(5) General Requirements. Each of the seven (7) members must have a demonstrated interest in neighborhood leadership issues, including, without limitation, neighborhood business groups, homeowner or condominium associations and cooperatives, civic groups, and/or other similar qualifications.

(6) Ex officio Normandy Fountain Business Association member. The nonvoting ex officio representative of the Normandy Fountain Business Association shall be nominated by the association and subject to the approval of the city commission.

Planning Board

Composition:

For Planning Board powers and duties, please refer to Sec. 118-51 of the Miami Beach Code of Ordinances.

(a) The Planning Board shall be composed of seven regular voting members. Each regular member shall be appointed with the concurrence of at least four members of the city commission. Each regular voting member shall serve for a term of two years. The planning director or designee, and the city attorney or designee, shall serve in an advisory capacity.

(b) All regular voting members of the board shall have considerable experience in general business, land development practices or land use issues; however, the board shall at a minimum be comprised of:

- 1. One architect registered in the State of Florida; or a member of the faculty of a school of architecture in the state, with practical or academic expertise in the field of design, planning, historic preservation or the history of architecture; or a landscape architect registered in the state of Florida; or a professional practicing in the fields of architectural or urban design, or urban planning;
- 2. One developer who has experience in developing real property; or an attorney in good standing licensed to practice law within the United States;
- 3. One attorney licensed to practice law in the State of Florida who has considerable experience in land use and zoning issues;
- 4. One person who has education and/or experience in historic preservation issues. For purposes of this section, the term "education and/or experience in historic preservation issues" shall be a person who meets one or more of the following criteria:

- a. Has earned a college degree in historic preservation;
- b. Is responsible for the preservation, revitalization or adaptive reuse of historic buildings; or
- c. Is recognized by the city commission for contributions to historic preservation, education or planning;

5. Two (2) persons who are residents at-large and who currently reside in the city and have resided in the city for at least (3) three consecutive years at the time of appointment or reappointment. Additionally, strong preference shall be given to individuals who have previously served on a Miami Beach board or committee and/or completed the Miami Beach Leadership Academy course, and to individuals not currently working in the fields of real estate development, real estate brokerage/sales, real estate law, or architecture; and

6. (a) A licensed professional engineer, licensed professional architect, or licensed professional landscape architect with expertise in water resources; (b) a person licensed by the State of Florida in hydrology, water or wastewater treatment; (c) a person with a degree from an accredited college or university in a field of study related to water resources; (d) a floodplain manager or a principal community administrator responsible for the daily implementation of flood loss reduction activities including enforcing a community's flood damage prevention ordinance, updating flood maps, plans, and policies of the community, and any of the activities related to administration of the National Flood Insurance Program (NFIP) (a "water management expert"); or (e) a person who is a resident at-large and currently resides in the city and has resided in the city for at least three consecutive years at the time of appointment or reappointment.

(c) Except as provided in subsection (b)(5) no person except a resident of the City, who has resided in the City for at least one year, shall be eligible for appointment to the Planning Board. The residency requirement in this subsection (c) shall not apply to the water management expert appointed to the planning board pursuant to subsection (b)(6).

(d) The City Commission may waive the residency requirements by a 5/7ths vote in the event a person not meeting these requirements is available to serve on the Board and is exceptionally qualified by training and/or experience.

(e) Each voting member of the board shall be required to complete an architectural walking tour offered by the Miami Design Preservation League (MDPL), which includes the National Register Architectural District in South Beach and an historic district in North Beach. In the event tours offered by MDPL are no longer available, this requirement may be satisfied by completing a similar architectural tour conducted by an educational or nonprofit organization as may be approved by resolution of the city commission. Members shall use their reasonable best efforts to complete the tour within sixty (60) days of their initial appointment.

Program for Public Information (PPI) Committee

Resolution No. 2022-32390 / 2023-32844 / 2024-33415

Composition:

The goals of the Federal Emergency Management Agency's ("FEMA") National Flood Insurance Program ("NFIP") are to provide flood insurance to property owners, to encourage flood loss reduction activities by communities, and to save taxpayers' money.

The City of Miami Beach participates in the NFIP and the Community Rating System ("CRS"), a voluntary program that provides both incentives and tools to further these goals.

The Program for Public Information ("PPI") provides activity points to improve the City's CRS score, which in turn helps to reduce flood insurance premiums.

An advisory ad hoc Resiliency Communications Committee was first created per Resolution No. 2016-29585 to serve as a PPI Committee from October 1, 2016, through October 1, 2017; and annually thereafter.

The current PPI Committee was created, pursuant to Resolution 2023- 32844, and will expire on December 31, 2024; therefore, a new PPI Committee would need to be created.

A PPI was developed by the initial ad hoc PPI Committee, according to a seven-step planning and public involvement process, defined by the CRS Program, and the PPI was adopted by the Mayor and City Commission per Resolution No. 2017-29771.

A new PPI is required every five-years and was developed by the ad hoc PPI Committee to update and replace the 2017 PPI, and the PPI was adopted by the Mayor and City Commission on July 20, 2022, per Resolution No. 2022-32216.

An evaluation report is prepared annually by a PPI Committee and submitted to the City Commission on October 28, 2024, the PPI Committee, that was created per Resolution No. 2023-32844, approved the Annual Update and Evaluation Report to be transmitted to the City Commission.

The City Manager recommends that the Mayor and City Commission accept the 2024 Report, attached to Resolution 2024-33415.

The members of the new ad hoc advisory PPI Committee (the "Committee") shall be as follows: the City's Communications Director; the City's Floodplain Manager; Scott Diffenderfer, a real estate agent; Carlos Gutierrez, a real estate agent; Alex Carrasco, a local bank representative; and John Lee, a local insurance agent.

The powers and duties of the Committee will be to serve as a PPI Committee in accordance with NFIP requirements for credit under the CRS, to implement, monitor, and evaluate the PPI, and to submit an annual evaluation report of the PPI to the City Commission.

The term of membership on the new ad hoc Committee shall commence on January 1, 2025, and expire on December 31, 2025, subject to earlier or later sunset by the City Commission.

Business shall mean any sole proprietorship, sponsorship, corporation, limited liability company, or other entity or business association.

On an annual basis, the members of the committee shall elect a chairperson and such other officers as may be deemed necessary or desirable, who shall serve at the will of the committee. Seven members shall consist of a quorum of the committee and shall be necessary in order to take any action.

Composition:

The Purpose of the Youth Commission is to provide the youth of Miami Beach with a vehicle to learn about government, participate in the process of City government, represent and articulate the needs of youth in the City, and provide recommendations to the Mayor and City Commissioners on issues and programs affecting the youth and teen population in the City.

- (a) The Youth Commission shall be composed of seven (7) voting members.
- (b) The Mayor and each City Commissioner shall appoint one member to the youth commission as a direct appointment. Members must be residents of the City of Miami Beach. Members must be enrolled in a public or private school in Miami-Dade County. Members shall be 15 through 18 years old at the time of appointment and be enrolled in the 10th, 11th, or 12th grade. To be qualified for appointment, a student must have a minimum 2.0 grade point average and demonstrate a sincere interest in municipal government, be motivated to contribute to the betterment of the city and have a background in community-based activity.
- (c) The term of office for each member shall be one (1) year. Members may be appointed for two subsequent one-year terms; provided, however, that no member shall serve on or after his/her nineteenth (19th) birthday. In addition, board member terms shall automatically expire upon the latter of December 31 of the year of the appointing City Commission member leaves office or upon the appointment/election of the successor City Commission member.
- (d) Youth Commission Members shall annually elect a member as chairperson, and other officers it deems necessary. A vote of a majority of the members shall be required to constitute action taken by the Youth Commission.
