### **RECOMMENDATION**

### **BACKGROUND/HISTORY**

Please place the above item on the February 26, 2025 City Commission meeting agenda as a referral to the Land Use and Sustainability Committee (“LUSC”).

Many sidewalks in the City of Miami Beach incorporate a “Miami Beach Red” color standard (a distinctive reddish/pink color), while others incorporate a natural gray concrete color. There has been discussion over the years and a conflicting record over the historical use of “Miami Beach Red” sidewalks.

In 2019, the City Commission approved the gradual replacement of gray concrete sidewalks with the “Miami Beach Red” color standard, unless otherwise specified by an applicable City Land Use Board. The Commission also delegated authority to the Public Works Director to determine where the use of Miami Beach Red sidewalks is appropriate.

For streets with “Miami Beach Red” sidewalks, I would like the LUSC to review design options and maintenance strategies to ensure these sidewalks remain distinctive, safe for pedestrians, aesthetically consistent, and historically appropriate.

A related item is pending before the LUSC to review where the City should install red sidewalks vs. sidewalks incorporating a natural gray concrete color.
