**RECOMMENDATION**

On May 15, 2024, the City Commission referred an item to committee to discuss and identify potential sites for the installation of *The Glory of Old Glory*, a series of murals by artist Enzo Gallo. These murals were removed, preserved, and donated to the city prior to the demolition of the Wells Fargo Bank on Alton Road. The item sponsor respectfully requests that the memo be updated to include consideration of the 72nd Street Complex as a potential installation site for the murals.
