The Festival is a multi-day event that brings together fitness enthusiasts, athletes, and spectators to celebrate health, wellness, and athleticism.

The Festival was held at Lummus Park Beachfront between 6th Street and 10th Street, showcasing various fitness competitions, vendor expos, and community activities, drawing thousands of participants and spectators to the City of Miami Beach.

### **ANALYSIS**

The organizers of the Event, Loud and Live Inc., are requesting for the City to waive its portion of the Boucher Brothers displacement fee required per the Boucher Brothers Concession Agreement in the approximate amount of \$44,565.42.

The City has granted similar waivers for event organizers for the 2022 and 2023 World Polo League Beach Polo World Cup events via Resolutions 2022-32116 and Resolutions 2023-32580.
