RECOMMENDATION

LAWSUITS FILED BY OR AGAINST THE CITY OF MIAMI BEACH SINCE THE LAST REPORT.

1. JOHN JOLIAT v. CITY OF MIAMI BEACH Case No. 2025-002548-CA-23 (Circuit Court of the 11th Judicial Circuit in and for Miami-Dade County, FL)

In his one-count negligence complaint, Plaintiff alleges that on May 22, 2024, he was riding his electric scooter at or near 13th Street and Michigan Avenue when his scooter struck an uneven surface that resulted in Plaintiff losing control of his electric scooter, causing him to sustain injuries. Plaintiff claims that the City of Miami Beach was negligent in creating and/or failing to correct the uneven surface.

The Office of the City Attorney will vigorously defend this matter.

2. ATHENE ANNUITY AND LIFE COMPANY v. JOHN SISNEROS, ET AL Case No. 2025-003261-CA-04 (Circuit Court of the 11th Judicial Circuit in and for Miami-Dade County, FL)

This is an action to foreclose a mortgage on real property located at 1601 West Ave, Unit 213, Miami Beach, FL.

The Summons and Complaint were served on the City on March 5, 2025.

The City's Answer and Affirmative Defenses will be timely filed.

3. CHARLES MCGOLDRICK v. CITY OF MIAMI BEACH Case No. 2025-002693-CA-23 (Circuit Court of the 11th Judicial Circuit in and for Miami-Dade County, FL)

This action arises from an alleged incident that took place on May 16, 2024, when Plaintiff "was walking southbound across 14th street" and "got his foot caught on a raised portion of the road when approaching the sidewalk." Plaintiff's one-count Complaint asserts a claim for negligence against the City.

The Office of the City Attorney will vigorously defend this matter.
