### **RECOMMENDATION**

Please place on the March 19, 2025 agenda a referral to the Public Safety and Neighborhood Quality of Life Committee to discuss potential "Taste of North Beach" restaurant crawl activation.

At its February 11, 2025, meeting, the North Beach Community Redevelopment Agency (North Beach CRA) Advisory Committee unanimously passed a motion requesting North Beach CRA staff to review the business inventory along the Collins Avenue commercial corridor and provide insights as to whether the Committee should support the exploration of a potential "Taste of North Beach" restaurant crawl activation.

I wish to support this request and refer this item to the Public Safety and Neighborhood Quality of Life Committee for discussion. I request that the Administration be prepared to provide an update on the business inventory review, as well as any logistical considerations, potential partnerships, and activation strategies that could support this initiative.
