RECOMMENDATION

BACKGROUND/HISTORY

ANALYSIS

The City of Miami Beach currently utilizes Granicus LLC's ("Granicus") OneMeeting software for agenda and meeting management. However, there have been recurring problems with the OneMeeting software, including performance issues, system instability, and the failure to implement critical features such as "Residents' Right to Know" and "MB Resident Connect." Despite repeated requests for support, Granicus has not been able to adequately resolve these issues in a timely manner.

In light of these challenges, I would like to discuss with my colleagues the potential development of a custom software solution tailored to the City's specific needs. This discussion will include considerations on cost, timeline, feasibility, and potential benefits of creating a more reliable and efficient system that can support the City's ongoing agenda and meeting management requirements.

The City must have proper tools to facilitate transparent and accessible communication for City meetings and, at this time, Granicus is falling short. The development of custom software could serve to enhance the overall experience for both staff and the public.

The Administration should be prepared to provide the necessary information for the Committee to make a recommendation to the Commission as to potential next steps.
