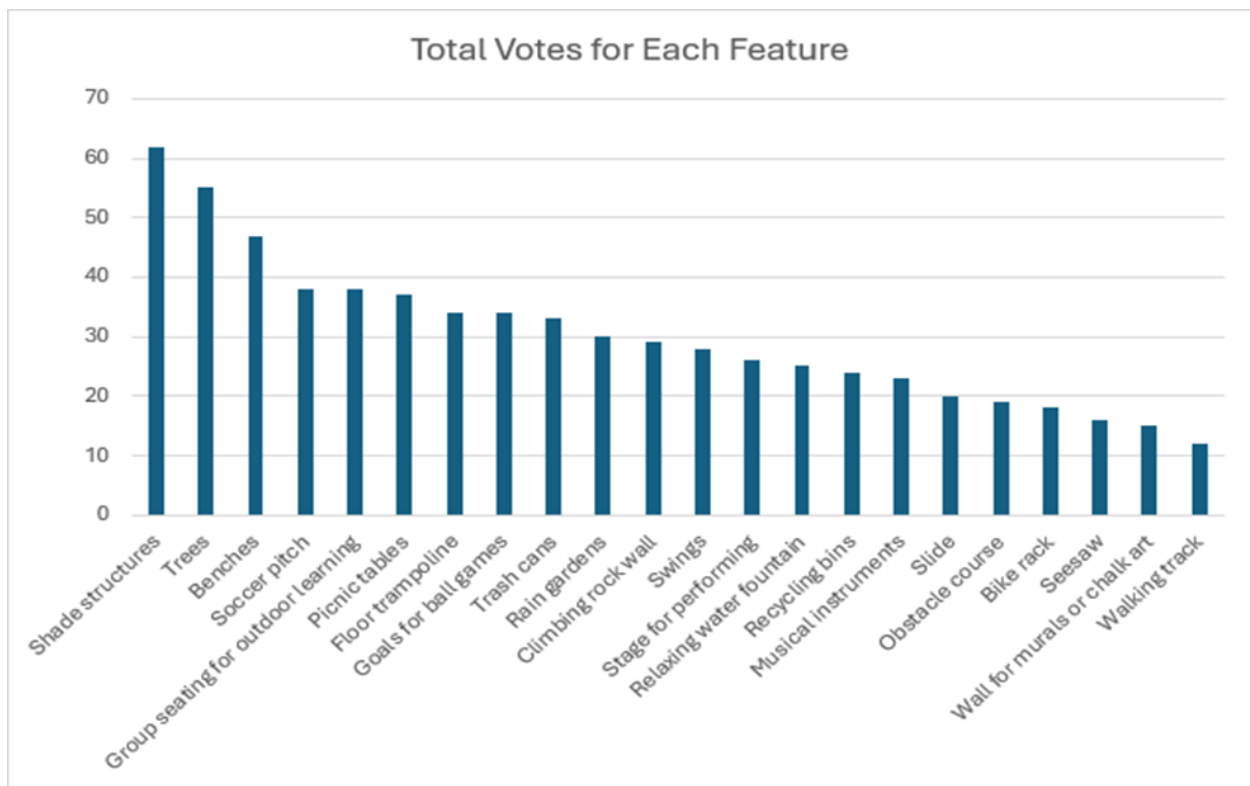
RECOMMENDATION

Administration is seeking direction regarding the Biscayne Beach Community Schoolyard project. Next steps would include the identification of funding as this is not a funded initiative. As the property is jointly owned, the City will explore shared funding opportunities with Miami-Dade County Public Schools (M-DCPS). Additionally, the City will continue to engage with the Trust for Public Land (TPL) to assist with the identification of potential donors.

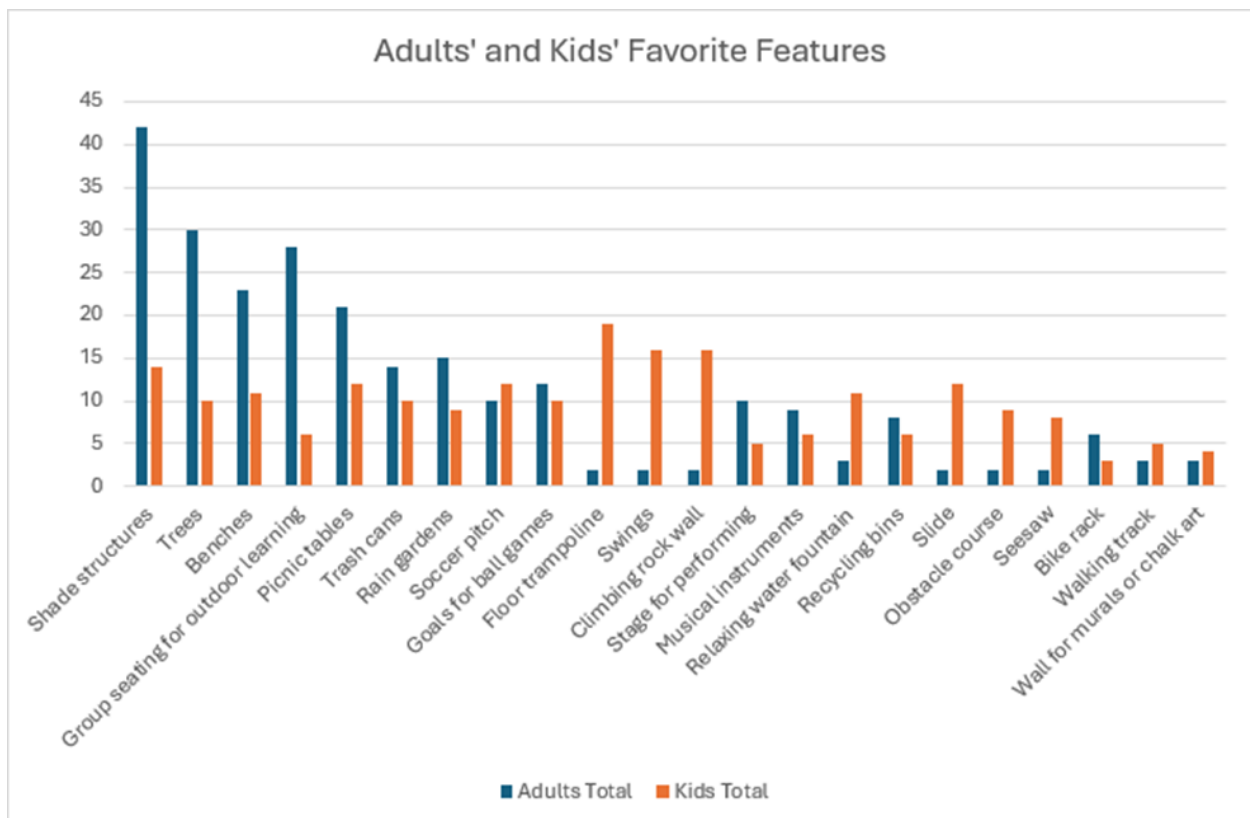
BACKGROUND/HISTORY

Resolution No. 2023-32551 was adopted approving a partnership with the Trust for Public Land and Miami Dade County Public Schools (M-DCPS) to engage the local Miami Beach community and partners to design a community schoolyard. A survey was developed to provide opportunities for the surrounding community and Biscayne Beach Elementary families to share their schoolyard preference and ideas. The survey yielded 138 responses in total, with 59 from adult community members and 79 from students.

Based on survey responses, some of the more popular features requested by the respondents to be considered in the design included shade structures, trees, and benches. Below is a chart of all requested features by survey respondents:



Breaking down the results between students and adults; however, shows that each group has unique preferences. Students were more likely to request active play equipment like trampolines, swings, and climbing walls, while adults were particularly interested in shade and various seating options like picnic tables and group learning spaces. The chart below reflects schoolyard feature preferences by adults and students:



In the open-ended survey questions available to adults, some of the feedback included the following:

- The park is big, relatively open, green/grassy and not cluttered, leaving lots of space to run around. Several people specifically expressed excitement around more soccer infrastructure.
- Concerns about the grass getting worn away (or not growing well under the trees), flooding, and kids getting dirty as a result.
- Concerns about security for this shared park space and some specifically requested lighting and/or security presence.
- Potential trash and vandalism if this space is more open to the public.
- Unique uses included a weekend farmer's market and a schedule of public artist events like instruction or performance in salsa, bluegrass, etc.

Students participated in activities throughout October 2024 and November 2024 that allowed them to meet the TPL project team and learn about environmental/design careers, brainstorm about the new schoolyard, dig into aerial photos and historical imagery of the site, and go outside to make sensory observations in the future schoolyard space. A design workshop was held for school students to provide their vision for the schoolyard as well.

ANALYSIS

As part of Phase II of the partnership, TPL met with and incorporated feedback from City staff and M-DCPS personnel to update preliminary concepts for the schoolyard (exhibit 1). Additionally, TPL has provided an opinion of probable costs for the construction of each concept (exhibit 2). The information presented to the City and M-DCPS personnel in January 2025 is attached for reference (exhibit 3).

The probable costs provided by TPL range from an estimated total of \$670,795.00 to \$690,046.00. TPL has no control over the availability of labor, equipment or materials, and market conditions. The probable costs provided was made on the basis of TPL's professional judgement and experience. Additionally, the probable costs were based upon conceptual designs only and not a guarantee of final costs.

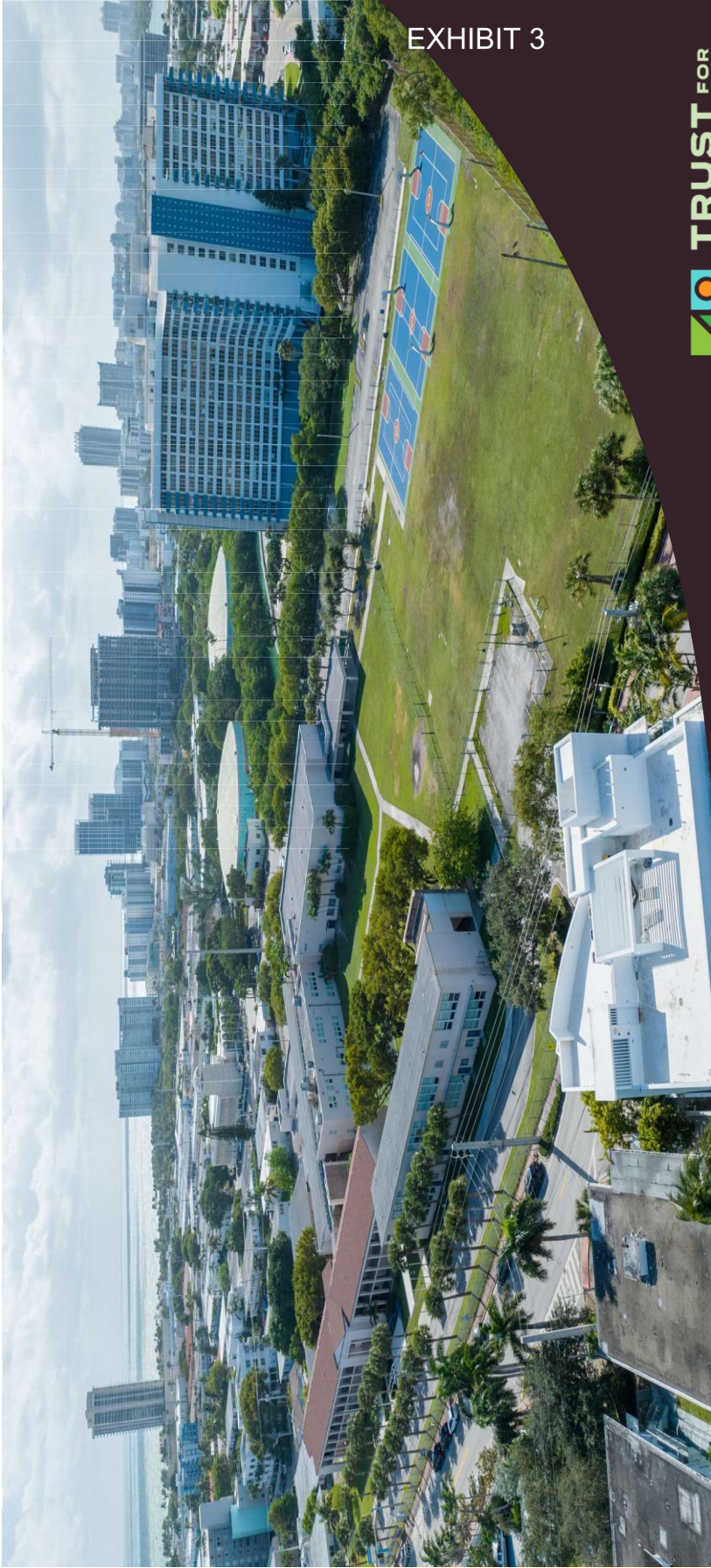

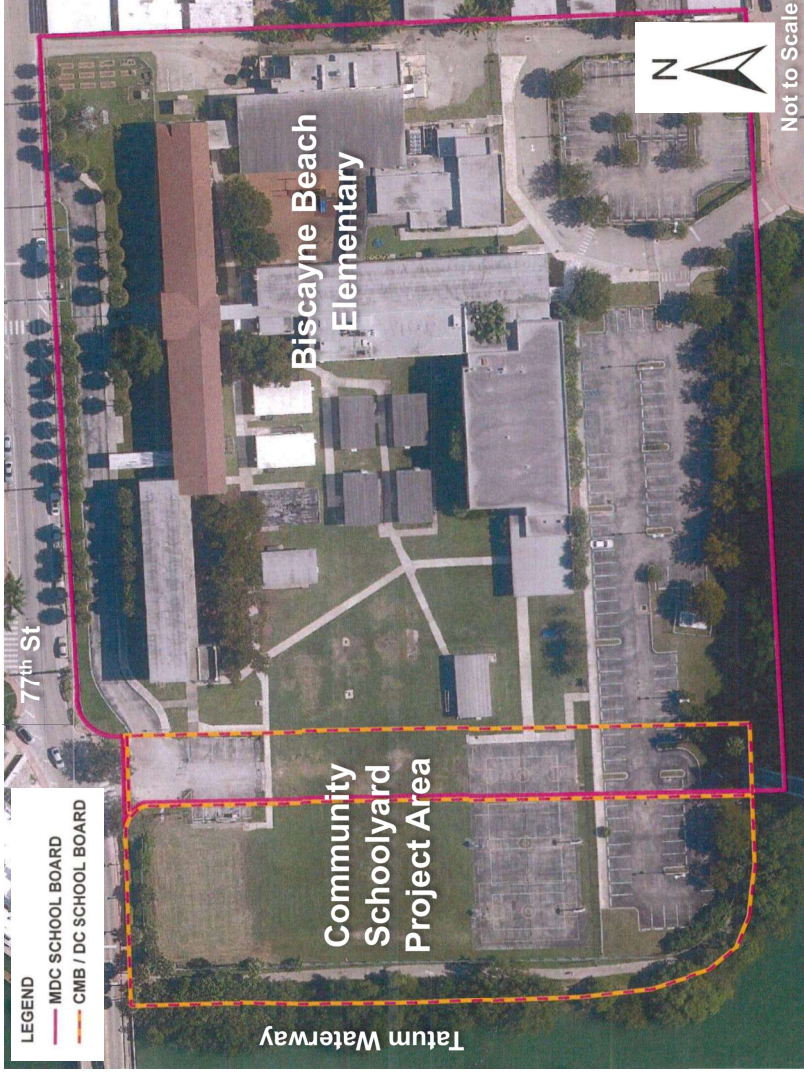
Biscayne Beach Elementary Schoolyard

Based upon the current joint use agreement, the structure to design and implement an enhanced public green space is in place

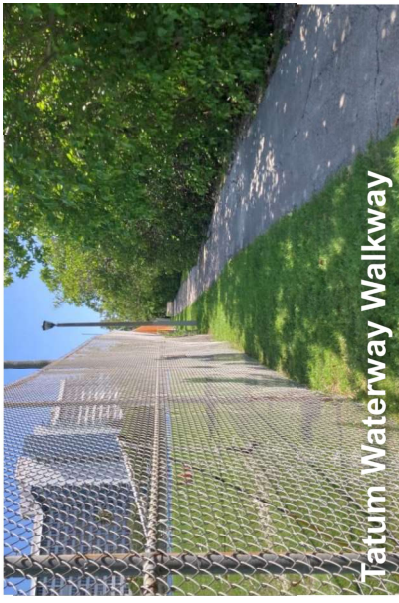


- MDCPC has a joint use agreement with City of Miami Beach

- Right now, plan is for conceptual design to be handed over to City and school district to hire and manage consultant and contractor to finalize design and construct

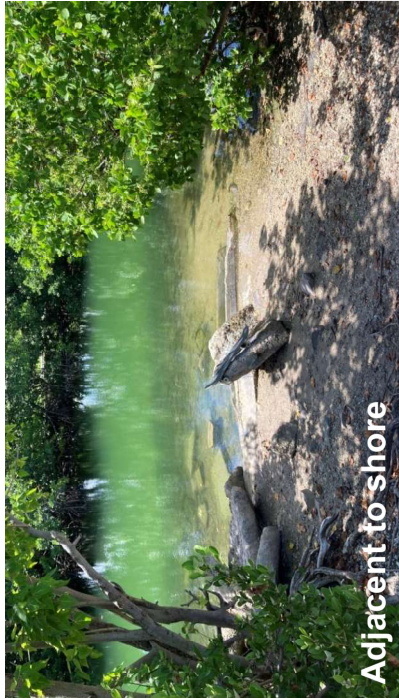

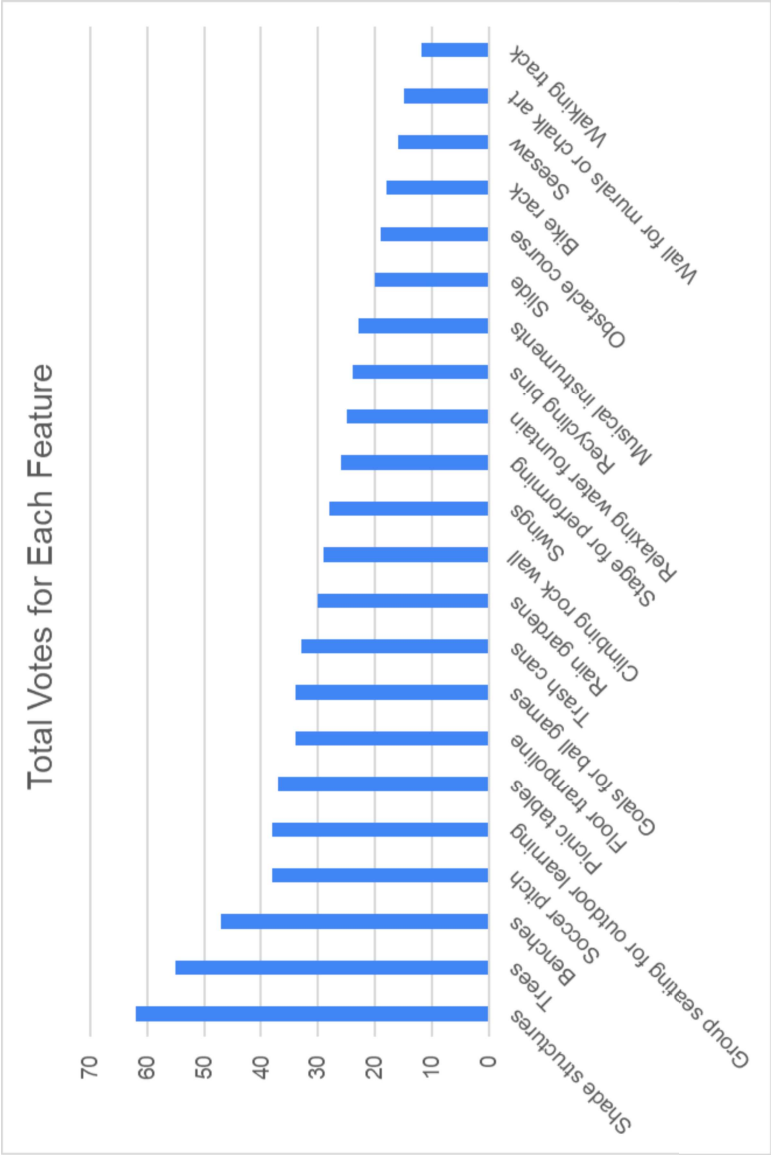

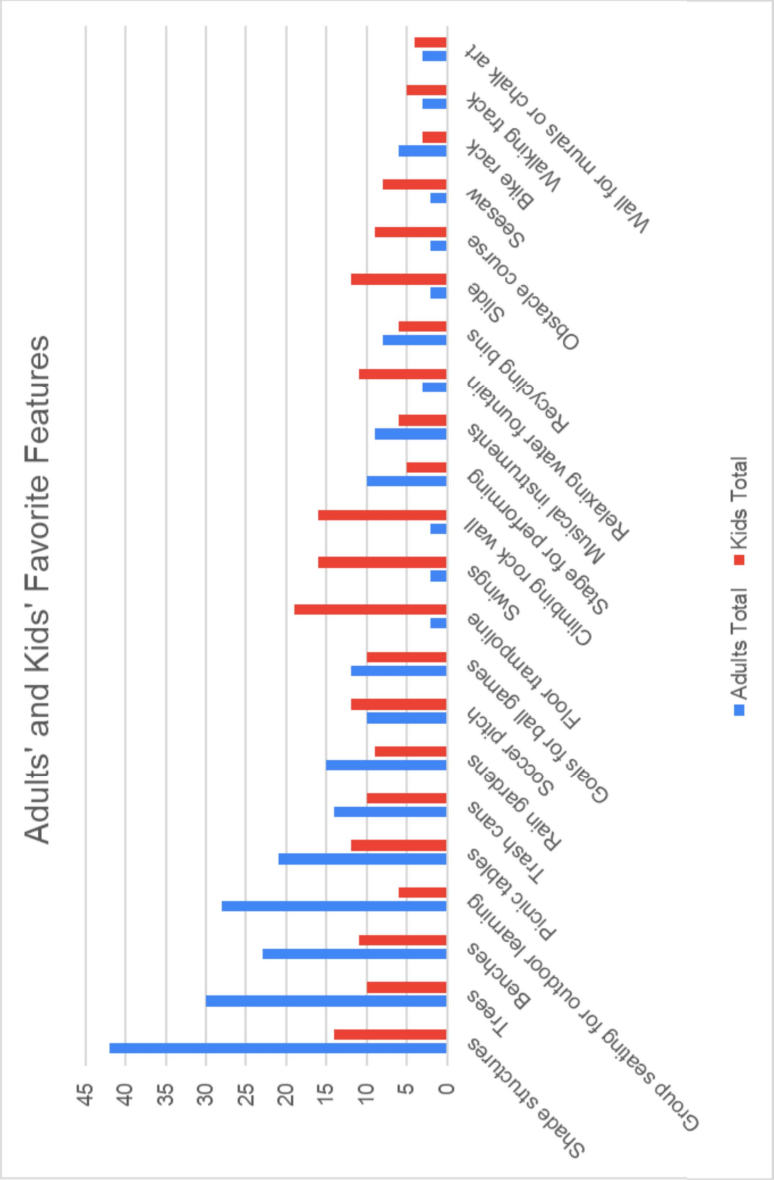
Biscayne Beach Elementary School Community Schoolyard Survey Results

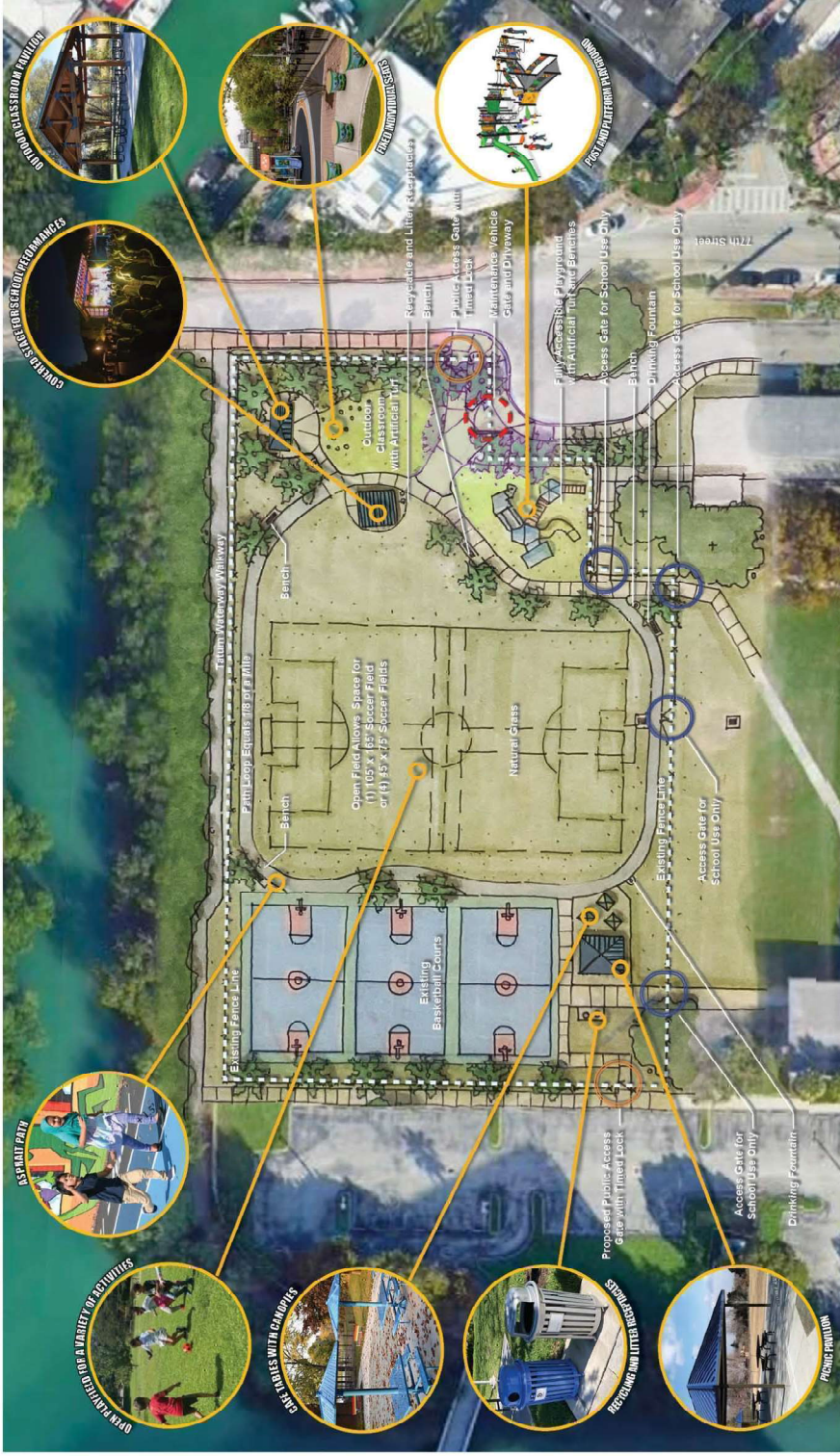


Biscayne Beach Elementary School Community Schoolyard Survey Results
