**RECOMMENDATION**

Please place on the March 19, 2025 agenda a referral to the Land Use and Sustainability Committee (the "Committee") to discuss the possible procurement of a new monument sign for Maurice Gibb Memorial Park.

**BACKGROUND/HISTORY**

As the Maurice Gibb Memorial Park (the "Park") has undergone a revitalization with new amenities and improvements, it would make sense to complement this renewal with a new monument sign that better reflects the upgraded space and welcomes visitors with a fresh, modern design. The contractor has already completed the refurbishment of the existing monument sign near the intersection of Purdy Avenue and Dade Blvd and has begun installing the surrounding landscaping. However, a new monument sign would serve to enhance the park's updated image and signify the City's commitment to revitalizing public spaces, while also creating a stronger sense of arrival for visitors.

**ANALYSIS**

I would like the Administration to be prepared to address the cost and timing for the design, permitting, fabrication, and installation of a new sign at Committee.
