TITLE: DISCUSS/TAKE ACTION ON ACTIVATING THE UNDERUTILIZED SPACES IN ALTOS DEL MAR PARK.

RECOMMENDATION

The Administration recommends that while the Public Safety & Neighborhood Quality of Life Committee evaluates activating the underutilized spaces in Altos Del Mar Park, it also carefully considers several critical factors that will significantly impact the General Fund budget, beginning in FY 2026:

- 1.The City's increasing unfunded capital improvement program
- 2.Long-term General Fund financial projections indicating a potential shortfall in upcoming fiscal years
- 3.The recent notification of a \$5-6 million annual budget impact on the General Fund due to the new 2% collection fee imposed by the Miami-Dade Tax Collector
- 4.The passage of Amendment 5 in November 2024, which increases the homestead exemption and further constrains the growth of taxable property values

These considerations are essential to ensure that decisions regarding activating the underutilized spaces in Altos Del Mar Park align with the City's broader long-term financial stability and strategic priorities. If the Committee recommends funding activating the underutilized spaces in Altos Del Mar Park for \$60,000, the Administration recommends it be considered as part of the FY 2026 budget process.

The Parks and Recreation Department will continue to work with Tourism and Culture and other City Departments to expand on additional potential opportunities.

BACKGROUND/HISTORY

During the October 30, 2024 City Commission meeting, at the request of Commissioner Tanya K. Bhatt, the Mayor and City Commission referred a discussion item to the Public Safety and Neighborhood Quality of Life Committee ("PSNQLC"), to discuss/take action on activating the underutilized spaces in Altos Del Mar Park. (Exhibit A)

At the December 13, 2024 PSNQLC meeting, the item was discussed, and staff was instructed to prepare a proposal that includes outdoor performances and temporary art installations at Altos Del Mar Park to explore funding options.

ANALYSIS

Outdoor Performances:

The Parks and Recreation and Tourism and Culture Departments are working together to activate Altos Del Mar Park with outdoor performances and temporary art installations. The Departments

can host large-scale events like Fire on the Fourth, Movies in the Park, and other community activities such as Fantasy Theater productions. This space can act as a hub for artistic performances and family-oriented neighborhood events.

The Parks and Recreation Department hosted a Movie in the Park at Altos Del Mar Park on January 11, 2025 with over 150 attendees and on February 1, 2025 with over 100 attendees. Other upcoming events include Spring Eggstravaganza on April 5, 2025, Earth Day celebrations, Beach Tennis activations and a Family Archery Day. The Environment and Sustainability Department will host Turtle Fest in April 2025.

The Tourism and Culture Department will be hosting an OnStage! event for National Pet Month on Saturday, May 10, 2025 at Altos Del Mar Park from 5:00 p.m. to 9:00 p.m. that will screen the Dogville comedies "Barkies," a series of silent movies featuring a cast of all dog actors. Guests can bring their beloved pets to do interactive activities with Buen Provecho Collective and the Animal Services Department will be hosting dog adoptions throughout the event.

The Parks and Recreation Department would like to further expand the current programming at the park through a budget request of \$60,000.

Temporary Art Installations:

The Tourism and Culture Department is exploring a temporary art program, inspired by the Village of Bal Harbour's (the "Village") public art initiative "Unscripted Bal Harbour" (the "Program"). The Program is a public/private partnership comprised of cross-collaboration with various organizations and artists to enhance the area and has a partnership with a local commercial art gallery, Opera Gallery. At no cost to the Village, Opera Gallery loans the artworks to the Village. In a mutually beneficial partnership, the Village activates its public areas, and the Opera Gallery promotes its available artworks. These artworks are available for purchase; therefore, artworks may be rotated or on a temporary basis.

Currently, there are a total of five (5) works of art throughout various areas of the Village. Opera Gallery presents works it would like to display for approval from the Village. Opera Gallery is responsible for all of the program requirements including installation costs, insurance, and transportation. The Village does not subsidize this program.

At the December 13th PSNQLC meeting, the Tourism and Culture department staff presented a cross-sector collaboration with FIU College of Communication, Architecture and the Arts (CARTA)'s Sculpture Department. The potential collaboration would allow for the Sculpture Department to showcase student's work at the end of each semester allowing for a temporary and rotating works of art. The PSNQLC recommended that staff contact North Beach gallery Jupiter, as well as other local visual arts non-profits. Below is an update for each.

Jupiter Gallery suggested working with their artist, Milo Matthieu. Matthieu would produce a prototype which would need to be sent to a fabricator to produce a large-scale bronze version of the work. Jupiter Gallery also shared details regarding the transportation and installation would need to be further discussed. Jupiter Gallery shared a desire to move forward and further discuss the timeline and costs of making, transporting and installing the sculpture.

The **Fountainhead Residency** shared the same feedback as Jupiter Gallery regarding production of new work and how the work would be installed. Fountainhead Residency also shared that the majority of their artists do not work in sculpture, and this requires large studio space and can be cost prohibitive to artists. Fountainhead is open to continuing a dialogue on a potential collaboration.

FIU-Miami Beach Urban Studios and CARTA Sculpture Department was enthusiastic regarding a potential collaboration and posed the same feedback as both Jupiter Gallery and Fountainhead Residency regarding installation.

At the time of this memo, staff has not met with **Oolite Arts** as their new CEO is slated to start the last week of January 2025 and the organization has asked that a meeting be scheduled.

Due to the landscape of Altos del Mar Park and lack of infrastructure to support a pilot sculpture program, the Tourism and Culture Department's Cultural Affairs Division is recommending the exploration of a temporary asphalt art installation on designated pathways to bring color and vibrancy to the park (Exhibit B). Should the desire of the PSNQLC be for staff to continue in the path of asphalt art, staff would need to determine implementation details not limited to the cost and timeline for such a project.

Other Considerations:

There are additional potential activations that may have the opportunity to be approved and funded through the North Beach CRA.

FISCAL IMPACT STATEMENT

The Parks and Recreation Department, along with the Tourism and Culture Department, will assess the budget impact according to the guidance provided by the Committee. In addition to current events, the Parks and Recreation would like to request an increase of \$60,000 to be considered during the FY 26 budget to further expand the programming activations at Altos del Mar Park.
