### **RECOMMENDATION**

Accept the recommendation of the Finance and Economic Resiliency Committee, at its November 8, 2024 meeting, directing Administration to negotiate a sponsorship agreement for the McKennie's Magical Youth Mission Foundation for youth soccer camps with resident scholarships up to \$50,000 waiver of facility fees, other in-kind expenses with the balance of a cash sponsorship, subject to a future budget amendment.

### **BACKGROUND/HISTORY**

During the October 30, 2024 City Commission meeting, at the request of Commissioner Joseph Magazine, the Mayor and City Commission referred a discussion to the Finance and Economic Resiliency Committee ("FERC"), to discuss potential financing for McKennie's Magical Youth Mission Foundation Youth Soccer Camps with the participation of the U.S. Men's National Team Players (Exhibit A).

During the November 8, 2024 FERC meeting, the Committee discussed the item and Commissioner Magazine motioned to have this item return to Commission with a favorable recommendation to direct the Administration to negotiate a sponsorship agreement for the McKennie's Magical Youth Mission Foundation for youth soccer camps with resident scholarships up to \$50,000. waiver of facility fees, other in-kind expenses with the balance of a cash sponsorship. Commissioner Bhatt seconded the motion and all present members were in favor. This recommendation is subject to a future budget amendment.
