**RECOMMENDATION**

Please place on the October 30, 2024, a referral to the Finance and Economic Resiliency Committee (the "FERC") to discuss the creation of a foundation focused on soliciting donations of works of art for the City's permanent Art in Public Places collection and/or temporary exhibitions.

**BACKGROUND/HISTORY**

The City of Miami Beach has long been committed to the enhancement of its public spaces through its Art in Public Places program (the "Program"), which aims to integrate high-quality, publicly accessible art throughout the City. The Program enriches the community, supports cultural engagement, and promotes Miami Beach as an international destination for the arts. To further this commitment, I would like for the FERC to discuss the potential benefits, structure, and feasibility of creating of a foundation whose specific focus would be to solicit and accept donations (or temporary installations) of works of art from individuals, corporations, and other benefactors. Such a foundation could serve as a platform for residents, art collectors, and art institutions to contribute to the cultural fabric of Miami Beach, ensuring a continuous enhancement of public art offerings. Further, the establishment of a dedicated foundation to solicit art donations represents an opportunity for Miami Beach to expand its Art in Public Places collection while fostering community engagement and philanthropy.

Key issues for consideration by the Committee include:

1. Foundation Structure: Evaluate the optimal organizational structure for the foundation, including governance, legal framework, and potential partnership models.
2. Funding and Management: Discuss operational funding and staffing needs, as well as costs associated with installation, maintenance, and insurance.
3. Integration with the City's AiPP Program: Review how the foundation's activities would align with and support the existing Art in Public Places Committee and the broader cultural initiatives of the City.
4. Community and Economic Benefits: Consider the cultural, social, and economic impact of enhancing the City's public art collection through such a foundation, including the potential to further elevate Miami Beach's standing as a global arts destination.
