WHEREAS, like housing, public restrooms are a basic need, a public health imperative, and a necessary piece of urban infrastructure; and

WHEREAS, there is a clear need for clean and safe public restrooms for use in the domino pavilions; and

WHEREAS, the existing infrastructure in North Shore Bandshell Park is not meeting this need.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby direct the City Administration to prioritize the installation of public restrooms in the domino pavilions in North Shore Bandshell Park.
