TITLE: REFERRAL TO THE PUBLIC SAFETY AND NEIGHBORHOOD QUALITY OF LIFE COMMITTEE TO DISCUSS ADDING A REQUIREMENT FOR SECURE AND ACCESSIBLE BICYCLE AND MICROMOBILITY STORAGE TO THE SPECIAL EVENT REVIEW PROCESS.

**RECOMMENDATION**

Please place the following item on the December 11, 2024, City Commission agenda a referral to the Public Safety and Neighborhood Quality of Life Committee ("PSNQLC"). As our city continues to host large-scale events like Art Basel, it is important that we encourage alternative, sustainable modes of transportation, such as bicycles and micromobility, to reduce congestion and environmental impact. To make these options viable and attractive for event attendees, there needs to be secure and accessible storage.

I propose that, as part of the Special Event Review Process, event organizers be required to include provisions for safe and convenient storage of bicycles, micromobility devices and related safety gear (e.g., helmets). This could include secure bicycle racks or valet services, so attendees have a safe place to store their equipment.

This will enhance the convenience of event attendees and also support our city's broader goals of reducing traffic and promoting sustainable transportation options. It may also make biking and micromobility a more attractive and practical mode of transportation for residents and visitors during large events. Additionally, venues like the Miami Beach Convention Center should also be encouraged to provide secure, easily accessible storage for these transportation options.

Accordingly, I would request the City Administration come prepared at Committee to discuss this proposal and provide feedback on the feasibility of implementing such a requirement.
