TITLE: A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING AN ANNUAL ALLOCATION OF \$3,000 TO EACH OF THE CITY'S SIX ADVISORY COMMITTEES ADDRESSING HUMAN AND CIVIL RIGHTS (I.E., THE HUMAN RIGHTS COMMITTEE, CITY OF MIAMI BEACH COMMISSION FOR WOMEN, DISABILITY ACCESS COMMITTEE, BLACK AFFAIRS ADVISORY COMMITTEE, HISPANIC AFFAIRS COMMITTEE, AND LGBTQIA+ ADVISORY COMMITTEE) IN THE TOTAL AMOUNT NOT TO EXCEED \$18,000 IN THE AGGREGATE, TO ENABLE THESE COMMITTEES TO SPONSOR EDUCATIONAL, COMMUNITY-WIDE EVENTS THROUGHOUT THE YEAR, SUBJECT TO CITY MANAGER'S APPROVAL.

### **RECOMMENDATION**

The City Administration ("Administration") recommends that the Finance and Economic Resiliency Committee ("FERC" or "Committee") discuss this item and provide input.

The Administration recommends that while the FERC evaluates an annual allocation of \$3,000 to each of the City's six advisory committees addressing human and civil rights, it also carefully considers several critical factors that will significantly impact the General Fund budget, beginning in FY 2026:

1. The City's increasing unfunded capital improvement program
2. Long-term General Fund financial projections indicating a potential shortfall in upcoming fiscal years
3. The passage of Amendment 5 in November 2024, which increases the homestead exemption and further constrains the growth of taxable property values

These considerations are essential to ensure that decisions regarding an annual allocation of \$3,000 to each of the City's six advisory committees addressing human and civil rights align with the City's broader long-term financial stability and strategic priorities. If the Committee recommends funding an annual allocation of \$3,000 to each of the City's six advisory committees addressing human and civil rights, the Administration recommends it be considered as part of the FY 2026 budget process.

### **BACKGROUND/HISTORY**

On February 26, 2025, Commissioner Alex Fernandez sponsored resolution (item C7W) for an annual allocation of \$3,000 to each of the City's six advisory committees addressing human and civil rights (i.e., the Human Rights Committee, City of Miami Beach Commission for Women, Disability Access Committee, Black Affairs Advisory Committee, Hispanic Affairs Committee, and LGBTQIA+ Advisory Committee) in the total amount not to exceed \$18,000 in the aggregate, to enable these committees to sponsor educational, community-wide events throughout the year, subject to the City Manager's approval.

Commissioner Suarez pulled the resolution from the consent agenda for discussion. The Commissioner expressed concerns that this action could lead to these Committees requesting additional funding in future years and lead other resident Committees to now begin requesting their own funding

The Mayor and City Commission ("City Commission") referred the item to FERC for discussion.

## **ANALYSIS**

Currently, if a Committee sees an event or an idea on a City expenditure, it passes a motion which goes to Commission via a Letter to Commission (LTC). A Commissioner then can sponsor a resolution to fund an event. The Administration does not track how many Committees' motioned ideas that could require City funding are sponsored by a Commissioner and attain funding. The Administration did reach out to the Committee liaisons to request information of funding requests related to events.

1. Human Rights Committee
  - a. Held a number of events including Red Sand Event in Pride Park and Human Rights Expo at Scott Rakow Youth Center which were funded by private donations.
2. City of Miami Beach Commission for Women
  - a. Per new liaison - no recent motions.
3. Disability Access Committee
  - a. Per Liaison - No funding related motions over the last two fiscal years.
4. Black Affairs Advisory Committee
  - a. In FY 2023 a motion for \$2,000 in funding was requested and it was sponsored by a Commissioner.
  - b. The current standing request \$3,000 in annual funding is part of this item.
5. Hispanic Affairs Committee
  - a. Per Liaison - No recent funding related motions
  - b. But City already funds \$3,00 for the Hispanic Heritage Awards Ceremony event.
6. LGBTQIA+ Advisory Committee
  - a. Per Liaison - No recent funding related motions

## **FISCAL IMPACT STATEMENT**

**WHEREAS**, the City of Miami Beach recognizes the importance of promoting human and civil rights, fostering inclusion, and empowering diverse communities; and

**WHEREAS**, the City has established several advisory committees, including the Human Rights Committee, City of Miami Beach Commission for Women, Disability Access Committee, Black Affairs Advisory Committee, Hispanic Affairs Committee, and LGBTQIA+ Advisory Committee, to address important issues related to civil rights, diversity, and inclusion; and

**WHEREAS**, these advisory committees play a vital role in raising awareness of key issues and advancing the City's commitment to equity and inclusion; and

**WHEREAS**, the City Commission desires to support the efforts of these advisory committees by providing financial resources to enable them to sponsor educational and community-building events throughout the year, subject to City Manager's approval; and

**WHEREAS**, as follows, the Mayor and City Commission hereby approve and authorize an annual allocation of \$3,000 to each of the City's six advisory committees addressing human and civil rights: the Human Rights Committee, City of Miami Beach Commission for Women, Disability Access Committee, Black Affairs Advisory Committee, Hispanic Affairs Committee, and LGBTQIA+ Advisory Committee, with the total annual allocation for these committees not to exceed \$18,000 in the aggregate, to be used for sponsoring educational and community-wide events that promote human and civil rights throughout the year.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA** that the Mayor and the City hereby approve and authorize an annual allocation of \$3,000 to each of the City's six advisory committees addressing human and civil rights (i.e., the Human Rights Committee, City of Miami Beach Commission for Women, Disability Access Committee, Black Affairs Advisory Committee, Hispanic Affairs Committee, and LGBTQIA+ Advisory

Committee) in the total amount not to exceed \$18,000 in the aggregate, to enable these committees to sponsor educational, community-wide events throughout the year, subject to the City Manager's approval.
