TITLE: REFERRAL TO THE FINANCE AND ECONOMIC RESILIENCY COMMITTEE TO CONSIDER A REDUCED PARKING RATE FOR MIAMI BEACH WORKFORCE, INCLUDING HOSPITALITY EMPLOYEES.

### **RECOMMENDATION**

The City Administration ("Administration") supports the implementation of a reduced parking rate for Miami Beach workforce, including hospitality employees, and recommends that the Finance and Economic Resiliency Committee ("FERC" or "Committee") discuss this item and consider a reduced parking rate for Miami Beach workforce.

### **BACKGROUND/HISTORY**

On February 3, 2025, at the request of Commissioner Alex Fernandez, the Mayor and City Commission ("City Commission") referred agenda Item C4 AT to the FERC, to consider a reduced parking rate for City of Miami Beach ("City") workforce, including hospitality employees.

The Administration recognizes the importance that workforce employees have on the City's economy and service industry as well as the challenges that many workforce employees experience on a daily basis, in terms of commuting to/from and parking in the City.

Currently, the City offers two (2) parking options for employees of Miami Beach businesses and hotels:

- 1) Employees or employers can purchase monthly access cards at the prevailing rate of \$128.00 per month to park at any garage in the vicinity; and
- 2) Employees or employers can purchase monthly municipal permits at certain parking lots in proximity at the prevailing rate of \$91.00 per month.

In addition, since 2008, the City offers a parking program for employees of businesses located along the Lincoln Road commercial corridor. Lincoln Road employees can choose to participate in the Employee Voucher Coupon – Lincoln Road ("EVC-LR") Program, which provides a reduced daily parking rate. This program allows employees to park at the 17 Street Municipal Parking Garage (G5) for a maximum daily rate of \$8.00. To participate in the EVC-LR Program, employers must register with the City's Parking Department and act on behalf of their employees. Once registered, employers will receive pre-programmed validation coupons. These coupons can be used at the facility's pay-on-foot stations in conjunction with the garage ticket. Employees who park more than four (4) hours will be able to use the coupons to pay the reduced daily rate of \$8.00 upon exit. Currently, approximately six (6) commercial establishments are participating in the EVC-LR program, utilizing approximately 900 employee vouchers on a monthly basis. The City staff will conduct additional outreach with the Lincoln Road Business Improvement District to ensure all current commercial and business establishments on and around Lincoln Road are aware of the EVC-LR program.

Furthermore, the Parking Department is currently working with various restaurants in the South of Fifth neighborhood to explore feasible parking options for their employees. Two (2) options are being considered as part of a pilot program, including purchasing permits to park in the Alton and Fifth parking garage at a cost of \$100 per month plus taxes and/or the South Pointe Elementary School parking lot at a cost of \$90 per month plus taxes. Discussions with the restaurant managers to further refine the parameters of the pilot program are ongoing.

## **ANALYSIS**

The Administration recognizes that the Miami Beach workforce, particularly employees in the hospitality sector, plays a vital role in the City's economy and service industry. Many of these workers, especially those employed in the hospitality sector, face the challenge of high parking rates when commuting to their jobs. To support the City's workforce and ensure that employees can affordably access their jobs, it is important to consider the implementation of a reduced parking rate(s) for hospitality employees. A reduced parking rate(s) would aim to alleviate financial burdens on employees, improve job accessibility, reduce employee turnover, and strengthen the hospitality industry in the City.

A discount program offering a reduced parking rate(s) for hospitality workers would provide more equitable access to employment, especially for those who may be struggling to make ends meet; help reduce the financial strain on workers, particularly those earning lower wages; and contribute to a more inclusive city.

Similar to the current EVC-LR program, to qualify for the reduced rate, employees would need to provide proof of employment through pay stubs, employee identification cards, or an official letter from their employer confirming employment. The reduced rates would apply at strategically located parking garages and lots near employment centers, particularly those located within walking distance of the hospitality and tourist districts.

An impact assessment of the proposed reduced parking rate(s) should be conducted to ensure that resident rates remain unaffected, while still offering affordable options for workers in need of relief. Currently, the resident rate is \$1.00 per hour, and it is important that employee rates do not fall below this amount to maintain fairness.

Furthermore, the existing rate structure should be reviewed to determine where adjustments can be made to accommodate the reduced rates. Outreach to Miami Beach business owners and hospitality employers would be conducted to gather input and feedback on a potential parking program for hospitality employees.

**RECOMMENDATION**
