TITLE: DISCUSS REQUESTING THE ADMINISTRATION TO EXPLORE THE FEASIBILITY OF ESTABLISHING A MUSCLE BEACH IN NORTH BEACH, CONSIDERING THE WIDELY RECOGNIZED POSITIVE IMPACT ON HEALTH, COMMUNITY, AND QUALITY OF LIFE OBSERVED AT MUSCLE BEACH IN SOUTH BEACH

RECOMMENDATION

The Administration recommends that while the Finance and Economic Resiliency Committee evaluates establishing a Muscle Beach in North Beach, it also carefully considers several critical factors that will significantly impact the General Fund budget, beginning in FY 2026:

1. The City's increasing unfunded capital improvement program.
2. Long-term General Fund financial projections indicating a potential shortfall in upcoming fiscal years.
3. The passage of Amendment 5 in November 2024, which increases the homestead exemption and further constrains the growth of taxable property values.

These considerations are essential to ensure that decisions regarding establishing a Muscle Beach in North Beach align with the City's broader long-term financial stability and strategic priorities. If the Committee recommends funding establishing a Muscle Beach in North Beach, the Administration recommends it be considered as part of the FY 2026 budget process.

BACKGROUND/HISTORY

During the February 26, 2025, City Commission meeting, at the request of Commissioner Joseph Magazine, the Mayor and City Commission referred a discussion item to the Finance and Economic Resiliency Committee ("FERC"), requesting the Administration to explore the feasibility of establishing a Muscle Beach in North Beach, considering the widely recognized positive impact on health, community, and quality of life observed at Muscle Beach in South Beach. ANALYSIS

Muscle Beach in South Beach is a symbol of fitness, wellness, and community engagement, attracting locals and visitors alike. It provides a space for physical exercise, social interaction, and can be linked to an increase in both physical activity and tourism, fostering a culture of health and vitality.

Given the success of Muscle Beach in South Beach, the Parks and Recreation Department is exploring the possibility of establishing a similar area in North Beach. Establishing a Muscle Beach in North Beach would offer similar benefits, including enhanced public health, improved quality of life, and the creation of a vibrant and active community space. The establishment of such a facility could help promote North Beach as a wellness destination and attract visitors.

The Parks and Recreation Department has reviewed different sites in North Beach and has identified Altos Del Mar Park as the top recommendation.

FISCAL IMPACT STATEMENT

The Parks and Recreation Department will work with the Office of Management and Budget to request additional funds through the FY 2026 budget process based on the direction given by the Committee. The final budget will be determined once the location is selected and the available space for equipment is assessed. Based on previous installations, the estimated cost of equipment could be around \$400,000; however, the exact price cannot be confirmed until the location is finalized
