█ **Report of the June 10, 2024, Land Use and Sustainability Committee (LUSC) Meeting.**

A Land Use and Sustainability Committee (LUSC) meeting was held on June 10, 2024. Committee Members participating were Commissioners Alex Fernandez (Chair), Tanya K. Bhatt (Vice-Chair), Laura Dominguez, and David Suarez. Commissioner Joseph Magazine also participated. Members from the Administration, including Thomas Mooney, David Gomez, Hernan Cardeno, Francisco Garcia, Ian Robinson, Manny Marquez, Amy Knowles, and Nick Kallergis from the City Attorney's Office, as well as members of the public, also participated.

The meeting was called to order at 4:05 p.m.
