**WHEREAS**, the U.S. Navy accepted Miami-Dade County's invitation to host Fleet Week at the Port of Miami on May 7 – 14, 2024, with the week-long event bring in excess of 800 service members to South Florida, and contributing to a growing understanding of the Navy's importance in our country's national defense; and

**WHEREAS**, Broward Navy Days, Inc. ("Producer"), the applicant/organizer for the Fleet Week Miami 2024 "Miami Beach Top Gun Beach Olympics" event (the "Event"), requested a waiver of City special event fees and fees for City services for the Event; and

**WHEREAS**, the Event was held at the Lummus Park Spoil area between 8 and 9 streets; and

**WHEREAS**, on April 3, 2024 the Mayor and City Commission adopted Resolution No. 2024-32995 approving the waiver of special event permit fees and City service fees in the total amount of \$20,528.37; and

**WHEREAS**, the Producer received an invoice from the City of Miami Beach in the amount of \$1,605.00 for Fire Department services (the "Fire Service Fees"); and

**WHEREAS**, the City service fees waived pursuant to Resolution No. 2024-32995 did not include the Fire Services Fees and the Mayor and City Commission desire to waive such fees.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA**, that the Mayor and City Commission hereby waive city service fees for Fire Department services in the total amount of \$1,605.00 for the Fleet Week Miami 2024 "Miami Beach Top Gun Beach Olympics" be held on May 11, 2024 at the Lummus Park Spoil Area between 8 and 9 streets.
