RECOMMENDATION

This referral was prepared and included on the agenda at the request of Commissioner Alex Fernandez.

BACKGROUND/HISTORY

Sponsoring Commissioner Alex Fernandez would like the Land Use and Sustainability Committee (LUSC) to initiate a review of the impacts from Invest 90L, a multi-day, intense, rainfall event, which caused significant flooding on local roadways and properties through the City of Miami Beach and Miami-Dade County.

On June 13, 2024, the City of Miami Beach declared a State of Emergency due to the flooding, followed by the Governor's declaration of a State of Emergency in South Florida and the Mayor of Miami-Dade County's issuance of a Declaration of Local State of Emergency on June 12, 2024.

Commissioner Fernandez would like the LUSC to review the areas of Palm Island, Hibiscus Island, Sunset Harbor, Sunset Islands 3 and 4, and Indian Creek, which were the first areas improved as part of the Neighborhood Improvement Plan, to determine whether the improvements enhanced the resiliency of these areas during the storm.
