Notice of Public Hearings and Adoption of Ordinance Amending the Pinecrest Code of Ordinances and Land Development Regulations

NOTICE IS HEREBY GIVEN that the Local Planning Agency (LPA) will hold a public hearing on Tuesday, July 9, 2024, 5:45 p.m. at the Pinecrest Municipal Center/Council Chamber, 12645 Pinecrest Parkway, Pinecrest, Florida, to consider the following proposed ordinance:

AN ORDINANCE OF THE VILLAGE OF PINECREST, FLORIDA, AMENDING THE PINECREST CODE OF ORDINANCES, CHAPTER 30, LAND DEVELOPMENT REGULATIONS, ARTICLE 5, ADDITIONAL REGULATIONS, DIVISION 5.15, OPEN AIR CAFE IN CONJUNCTION WITH A RESTAURANT, REVISING LOCATION, DESIGN, AND OPERATION REQUIREMENTS FOR ESTABLISHMENT OF OUTDOOR DINING; AND ARTICLE 7, SIGNS, DIVISION 7.13, PROHIBITED SIGNS, AND DIVISION 7.16, SIGN STANDARDS AND REQUIREMENTS TO ALLOW NON-COMMERCIAL FREESTANDING ELECTRONIC AND CHANGEABLE COPY MONUMENT SIGNS IN THE PS, PUBLIC AND SEMI-PUBLIC SERVICES ZONING DISTRICT; PROVIDING FOR INCLUSION IN THE CODE OF ORDINANCES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

The Village Council will hold a public hearing and consider the ordinance on Second Reading on Tuesday, July 9, 2024, at 6:00 p.m., at the Pinecrest Municipal Center/Council Chamber, 12645 Pinecrest Parkway, Pinecrest, Florida.

Proposed amendments to the Land Development Regulations include revisions to the requirements for location, design and operation of an outdoor cafe in conjunction with a restaurant, and revisions to permit non-commercial freestanding electronic and changeable copy monument signs within the PS, Public and Semi-Public Services zoning district, subject to compliance with illustrated design standards.

All interested parties are urged to participate. Live streaming video of the meetings will be available at www.pinecrestfl.gov/live. If you do not wish to attend the in-person meetings, public comments may be submitted in writing prior to the hearing via e-mail to planning@pinecrestfl.gov or on ZOOM during the meeting by sending a request to clerk@pinecrestfl.gov no later than noon on Tuesday, June 11, 2024.

Interested parties requesting information are asked to contact the Building and Planning Department by calling (305) 234-2121, via e-mail at planning@pinecrestfl.gov, or writing to the department at 12645 Pinecrest Parkway, Pinecrest, Florida 33156, where a copy of the proposed ordinance and amendments are on file.
