The city's general policy has been to represent elected officials when they are sued in their official capacity. But the matter was complicated in May when a city insurer, QBE Specialty Insurance, filed a lawsuit in federal court arguing that it cannot be held responsible for over \$10 million in legal fees for Carollo's defense in the Fuller- and Piniella-related lawsuits dating back to 2018, citing allegations that Carollo engaged in "deliberate, willful conduct that was intended to deprive plaintiffs of their property and harm plaintiffs' reputations to punish and retaliate." The lawsuit is ongoing.

As a city commissioner, Carollo earns a salary of \$58,200 a year, according to a city spokeswoman. Based on Carollo's financial-disclosure forms, he would not be able to pay for legal fees out of pocket. In his most recent disclosure, Carollo reported he has less than \$2,500 in his checking account — a decrease from the \$45,431 that he reported last year. Carollo told the Herald the money was spent on various expenses, including living expenses. In the 2022 financial-disclosure form, which reflected Carollo's finances through the end of 2021, he reported about \$100,000 in the checking account. He reported

nearly \$121,300 in the account at the end of 2020, over \$11,700 at the end of 2019 and under \$7,000 at the end of 2018.

Carollo reported a net worth of \$1.76 million in his disclosure for 2019, \$1.87 million in 2020, \$2.36 million in 2021 and \$2.35 million in 2022. During that time, he reported that the value of his Coconut Grove home increased from \$2 million to \$2.5 million.

Besides his checking account and his home, Carollo's other major asset is his retirement plan, which is currently worth about \$46,430, according to the latest disclosure.

ing body recommended a one-year suspension for Tess Jaden Segal, 20, of Weston, and Allan Hektor Frasher, 21, of Largo, but UF suspended Segal for three years and Frasher for four years.

The university suspended Roseanna Yashoda Bistran, 20, of Ocala, for three years, the same duration as the hearing body recommended. Augustino Matthias Pulliam, 20, a freshman theater major from Jacksonville, also was suspended for three years.

The students said they have submitted appeals to overturn their punishments.

The suspensions mean that each would need to reapply for admission to UF. The only worse punishment would have been to expel them, which would have prevented them from returning.

Meanwhile, all the people arrested at UF said they have turned down deferred-prosecution agreements offered to them by the Alachua County State Attorney's Office. Under such deals, a defendant would plead no contest or guilty and the charges would effectively be dropped from their records if they committed no more crimes during a period of time, usually 12 months. None of the nine had any prior criminal convictions.

"We did not resist arrest, and we are prepared to fight our charges," Hovis said in a written statement. "We're standing in solidarity with each other, and collectively demanding that the state drop the charges against us."

Their court cases were expected to unfold during the summer. The state attorney, Brian Kramer, is a Republican facing reelection in November.

Of the nine, Ember Boerboom, 24, of Chesapeake, Virginia, was a former UF student; Charly Keanu Pringle, 21, of Jack-

sonville, was a former Santa Fe student; and Jinx Rooney, 23, of Valrico, had no apparent affiliation with the university.

All faced misdemeanor criminal charges of resisting arrest without violence except Frasher, whom prosecutors charged with felony battery on a police officer. Hovis also faces another misdemeanor, a trespass charge. Police said Hovis declined to say whether he would leave, so they arrested him.

Under university disciplinary rules, Summerlin was permitted to reject the recommendations of the hearing bodies, which are typically composed of faculty members. Summerlin — who started his job at UF in April, the same month as the arrests — declined Tuesday through a spokesperson to say why he handed out tougher-than-recommended sanctions in nearly every case.

'I STAND IN SOLIDARITY WITH PALESTINIANS'

The outcomes of the disciplinary hearings — which happened during May and June — were described in a news release Tuesday distributed by the students. The privacy of the school's disciplinary process is protected under federal law, and only the students involved can lawfully disclose what happened behind closed doors. Two of the UF students, including Segal, are Jewish, they said.

"I stand in solidarity with Palestinians not in spite of my Judaism, but because of it," she said in a written statement.

Meanwhile, newly released law-enforcement video appears to capture the moment when one of them was accused of spitting on a police officer in the most serious case.

Prosecutors have accused Frasher of spitting on the right arm of university police officer Kristy Sasser as she was helping a state trooper walk away with another protester under arrest. Sasser,

who also testified in at least one university disciplinary hearing, said in court papers that Frasher "walked up to us and spit on me. His spittle landed on my right arm. I disengaged from the escort and arrested Frasher for battery."

In video of the arrests obtained from the Highway Patrol under Florida's public-records law, Frasher is seen fidgeting with a water bottle with a medical-style mask down to his chin, joining the crowd in screaming "shame" at the officers arresting their peers.

As Sasser walked by, the top part of Frasher's body appeared to lurch sharply toward her as he held a water bottle. Sasser turned and appeared seconds later behind Frasher to arrest him. Frasher is expected at a court hearing on July 24 for an update in his case.

UF President Ben Sasse, during a May press conference, praised police. "What you have done in the face of being spit on, being shouted at with profanities has been amazing."

The university has declined so far to release other police video showing the arrests despite a reporter's request for copies on April 30 under state law. The school also hasn't turned over requested copies of communications among its general counsel, Sasse and police departments.

One of the government's expected witnesses in the criminal trials for the defendants is identified in court records as Aaron Michael Sarnar, 24, of Hollywood, a UF law student listed as vice president of the group Students Supporting Israel. Sarnar did not respond to phone calls or messages over several days asking about his role in the cases.

Biden looks to Black, Latino leaders to put down party uprising

Joe Biden is turning to Black, Hispanic and progressive leaders to curb an intraparty uprising over his fitness for office, an unexpected lifeline for a president whose standing among voters in those groups has diminished. Biden this week has drawn battle lines in the Democratic Party's struggle over whether he should remain its presidential nominee. Some of his staunchest defenders have been lawmakers of color, bolstering Biden's case that he has rank-and-file support while he chastised "elites" for voicing concerns that his age, calamitous debate performance and faltering speech will usher Donald Trump back into the White House.

Biden's fate remains unclear. Many other Democrats have expressed fear the president's insistence on staying in the race risks a Republican sweep in November. Another poor showing, in a Thursday press conference at the NATO summit or afterward, could spell the end for Biden's run.

For now, support from key groups — for reasons ranging from loyalty to reality — has substantially slowed momentum behind an effort to force him out that could result in a mutually assured destruction of both factions.

"He is leaning on what he knows," said Democratic strategist Antjuan Seawright. "The reason why Joe Biden was our nominee and the reason why he's president is because of his unwavering, undebatable, undisputed relationship with Black people."

Representative Maxine Waters of California, one of the most senior Black women in Congress, said Biden had earned support with his policies on education and drug prices and his personnel choices, including Vice President Kamala Harris, the nation's first Black female No. 2.

"We have to move forward with Joe Biden," she said Tuesday in a SiriusXM radio interview.

Black communities have long formed the backbone of the Democratic Party. But polls have shown Biden underperforming with Black voters who have expressed concern about inflation, slow progress on civil-rights issues and the president's support for Israel in its war in Gaza. Trump, meanwhile, has sought to make gains with Black voters.

That could make it difficult in the long run for Biden to prop up his candidacy using Black support. The president's effort to differentiate between Democratic elites and the diverse voting base could also sow further divisions. But as the biggest political crisis of Biden's presidency has unfolded, his backing among Black elected leaders has become evident. It was on display when Biden met virtually on Monday with the Congressional Black Caucus to rally support and lay out his path to victory.

"There will be no other nominee than President Biden," Representative Steven Horsford, the caucus chairman from battleground Nevada, said on CNN after the meeting.

Biden has announced numerous events to signal he has no intent of stepping aside, including trips to Detroit and Las Vegas, where he'll speak to the NAACP National Convention, and a Wednesday speech to the AFL-CIO

Pelosi suggests Biden should reconsider decision to stay in race

WASHINGTON — Rep. Nancy Pelosi, D-Calif., the former House speaker, suggested on Wednesday that President Joe Biden should reconsider his decision to remain in the presidential race, the strongest public push yet from a senior member of his party for him to weigh dropping out.

Despite mounting concerns that his candidacy could cost Democrats not only the White House but both chambers of Congress, Biden has been unequivocal about his intention to seek a second term, telling members of Congress in a letter on Monday that his mind is made up and "I'm firmly committed to staying in this race." On Wednesday, Pelosi said on MSNBC's "Morning Joe" that the president should continue to weigh his options.

"It's up to the president to decide if he is going to run," she said. "We're all encouraging him" to make that decision. "Because time is running short."

When pressed on whether she wanted him to seek reelection, Pelosi said: "I want him to do whatever he decides to do. And that's the way it is. Whatever he decides, we go with." Pelosi said she wanted to delay the conversations about Biden's future until after the NATO summit he is hosting this week in Washington. Today, Biden will have his first news conference since his disastrous debate performance, which raised questions about his mental acuity and fitness to remain in the race.

"The base is getting fired up," said Biden campaign co-chair Cedric Richmond. "If you stand up and fight for the Black community, the Black community will stand up and fight for you."

Harris on Tuesday met with members of the U.S. men's Olympic basketball team, including Joel Embiid, Stephen Curry and LeBron James, in Las Vegas ahead of a campaign event. Harris will also deliver speeches this month to two historically Black sororities.

'BRUNG ME TO THE DANCE'

Biden's strategy is one he's used in the past. When his 2020 primary run was on the precipice of failure, an endorsement from prominent Black lawmaker Jim Clyburn propelled Biden to a roaring victory in South Carolina that ultimately vaulted him to the nomination.

"You all brung me to the dance," Biden often tells Black voters, a phrase he also uses with unions.

Biden has also received backing from what has generally been his weakest flank: progressives. But some have sounded more resigned than buoyant about supporting him.

New York Representative Alexandria Ocasio-Cortez, a member of the "Squad" of young progressive lawmakers, said she spoke to Biden over the weekend and concluded he's steadfast in running. "The matter is closed," she told reporters Monday on

Capitol Hill.

The heads of the Congressional Hispanic Caucus have supported Biden, while stopping short of explicitly saying he should remain the nominee. Trump has also sought to make inroads with Latinos, a group Biden carried by more than 20 percentage points in 2020.

"We stand with President Biden and Vice President Kamala Harris," said Chair Nanette Barragán and Deputy Chair Adriano Espaillat.

Some 55% of respondents in seven swing states thought Biden should probably or definitely drop out, according to a Bloomberg News/Morning Consult poll taken July 1-5. Only 31% of Black respondents agreed.

Biden received a hero's welcome on Sunday at a Black church in Philadelphia. Some of his first interviews after the debate were with Black radio stations — an approach that ultimately backfired when it was revealed his campaign fed questions to some interviewers.

Black voters are concentrated in several swing states that will decide the election. Biden launched an ad campaign in Philadelphia on Tuesday accusing Trump of being hostile to Black people.

Biden's appearances have reinforced his perceptions about his candidacy's viability, even as polls show him trailing Trump due to voters' doubts about his age, acuity and ability to serve a second term.

Djokovic in Wimbledon semis after de Minaur withdraws

Novak Djokovic advanced to his record-tying 13th Wimbledon semifinal after Australia's Alex de Minaur withdrew due to a hip injury on Wednesday. Scheduled to face Djokovic in the quarterfinals, de Minaur admitted that he injured his hip in the closing stages of his 6-2, 6-4, 4-6, 6-3 win over Arthur Fils in the fourth round on Monday. After attempting to warm up for less than eight minutes early in the day, de Minaur notified Wimbledon officials and Djokovic's camp he would be unable to recover in time to challenge the second-seeded Djokovic.

"I'm devastated, but I had to pull out due to a hip injury, a little tear of the fiber cartilage that is at the end of the adductor," de Minaur said. "I felt a loud crack during the last three points of my match against Fils and got a scan yesterday and it confirms that this was the injury. [There is] a high risk of making it worse if I was to step on court."

With the walkover win, Djokovic is tied with Roger Federer for the most Wimbledon semifinal appearances by a man in tournament history.

The 37-year-old Serbian will square off Friday against No. 25 seed Lorenzo Musetti. The Italian ousted No. 13 Taylor Fritz 3-6, 7-6 (5), 6-2, 3-6, 6-1 on Wednesday.

As for de Minaur, he said he was at peace with his decision despite the chance to defeat Djokovic for the second time this year.

"It's no secret that, at this stage of my career, this was the biggest match

of my career. So wanted to do anything I could to play," he said. "I got the results yesterday. I knew what the results were yesterday. I still wanted to wake up today hoping that I would feel some sort of miracle and not feel it while I'm walking."

"The problem with me going out and playing is that one stretch, one slide, one anything, can make this injury [recovery] go from three to six weeks to four months. It's too much to risk."

Meanwhile, Musetti reached the final four at a Grand Slam for the first time with his victory over Fritz in 3 hours and 27 minutes. The 22-year-old is just the fourth Italian man to reach the semifinals at the All England Club, joining Jannik Sinner (2023), Matteo Berrettini (2021) and Nicola Pietrangeli (1960).

Musetti dominated the decisive fifth set, posting 11 winners and breaking

Fritz's serve twice while his points all seven of his points at the net. "I don't think I've realized yet what I have done," Musetti said in his on-court interview. "I was talking with my team about how to play on the big stage... It was the first time I've had the opportunity to walk out on this amazing stadium and it's been an honor for me."

"At the start of the match Taylor was really leading the game, especially with his serve, and I couldn't return well. In the second set I had a big reaction after breaking at the start and that changed my mind, my attitude. That probably made the difference and hopefully on Friday I will have the same one."

Musetti finished the match with 35 winners and 39 unforced errors, compared to 41 and 55 for Fritz.

Mystics fend off furious Fever rally, big game by Caitlin Clark, 89-84

Ariel Atkins scored 26 points and the Washington Mystics survived for an 89-84 road victory over the Indiana Fever on Wednesday afternoon at Indianapolis.

Sofiane Dolson and Julie Vanloo added 15 points apiece, while Aaliyah Edwards and Shatori Walker-Kimbrough came off the bench for 12 and 10 points, respectively.

The Mystics (6-17) finished a four-game road stretch with a 2-2 mark, snapping a two-game skid. They also avenged two losses to Indiana.

Caitlin Clark, in her first game since becoming the first rookie in WNBA history with a triple-double, racked up 29 points, 13 assists and five rebounds. She made five 3-pointers and was good on four free throws in the last 65 seconds.

Kelsey Mitchell supplied 15 points for Indiana, but she was 0-for-8 on 3s.

The Fever (9-14) were mistake-prone with 23 turnovers, but they made a late 12-0 run to trim the deficit to 85-80. Later, it was 87-84 before a Vanloo free throw.

Atkins shot 10-for-17 from the field to boost Washington's shooting percentage, which was 44 percent. Vanloo connected on three 3-point shots.

The margin was 76-55 entering the fourth quarter. The Fever pulled within 77-68 on Clark's jumper with about six minutes left. Jade Melbourne and Atkins each hit two free throws before the Fever scored again.

The Mystics stormed out to a 33-19 lead early in the second quarter.

They took advantage of nine Indiana turnovers, while Vanloo drained a pair of 3-point shots. Washington received immediate offensive contributions from reserves; four bench players produced points across the game's first 12 minutes.

Indiana's early ball-handling problems negated the teams hot shooting for much of the first half. The Fever shot 53.4 percent for the game, including 53.6 percent before halftime.

The injury list has remained a factor for the Mystics, who were without Shkira Austin (thigh), Karlie Samuelson (hand) and Brittney Sykes (hip). Emily Engstler was back in action after missing Saturday's game with an illness. She finished with four points.

■ **Sky 78, Dream 69:** Chennedy Carter scored 19 points and rookies Angel Reese and Kamilla Cardoso both notched double-doubles to boost host Chicago over Atlanta on Wednesday.

Chicago outscored Atlanta 24-15 in the fourth quarter on the way to its third victory in the past four games.

The Dream have lost eight of nine, a slide that includes an eight-point

home loss to Chicago on July 2.

Marina Mabrey converted a three-point play to break a tie and put the Sky ahead 68-65 with 4:17 remaining in the game. Chicago (9-12) never relinquished the lead after that but the Dream stuck around.

Over the past three years, Cameron Boozier has dominated at the state and national levels.

Last week, the Columbus High basketball star shined on the global stage. On a team of prep stars, Boozier stood out while leading Team USA to the championship of the FIBA Under-17 World Cup in Istanbul.

Boozier scored 24 points in the final — a 129-88 victory over Italy — to earn TISSOT MVP honors for the tournament.

Boozier, a three-time Miami Herald Basketball

Player of the Year who has led Columbus to three consecutive state titles, averaged 20.1 points, 9.9 rebounds and 2.0 assists for the tournament.

Boozier, who is ranked the No. 2 overall prospect in the country by 247Sports, was joined on the roster by his brother Cayden, ranked No. 19, as well as other top prospects including Arizona's Koa Peat and Utah Prep's AJ Dybantsa — the top overall prospect. Cayden Boozier averaged 6.4 assists and 4.9 points for the tournament.

In four knockout rounds, USA beat the Philippines, Canada, New Zealand and Italy by an average margin of 67 points. The United

States' closest game was a 104-81 win in pool play against France.

Cameron Boozier, a 5-star prospect who is being recruited by college programs such as Duke, Kentucky, Miami, Florida and FSU, won Florida's Mr. Tamborland trophy as well as Gatorade and Max Preps Player of the Year honors.

After leading Columbus to a No. 2 national ranking

last season and a third consecutive state title, Boozier led the Explorers to a runner-up finish at The Throne national tournament and later to the semifinals of the Chicago Nationals before losing to national champion Montverde Academy.

STAR TRANSFERS

The Dade star who will be returning to try to extend his team's state championship streak is Dante Allen. After leading Riviera Prep to back-to-back state titles, Allen recently transferred to Montverde Academy.

Allen, a 6-3, 210-pound shooting guard who has multiple Division I offers (including Michigan and

Villanova), is ranked No. 80 overall in the nation by 247 Sports and was the Miami Herald's Class 4A-2A Player of the Year each of the past two seasons. He averaged 21 points, 7.8 rebounds, 3.4 steals and 3 assists.

The Bulldogs, who still return sibling guards Mason and Myles Fuentes as well as 6-10 center Gustavo Guimaraes, will compete in Class 2A instead of 3A starting next season after the FHSAA recently announced its new classifications for basketball.

Maduro played a hands-on role in Venezuela's drug cartel, unsealed indictment says

He might not have been among the first officials asked to participate when late President Hugo Chavez decided to get into the drug business, but current ruler Nicolas Maduro ended up playing a leading role and exerting great influence in the Cartel de Los Soles as his power inside Venezuela grew, according to a newly unsealed federal indictment.

A previously sealed indictment introduced in a federal court in New York against leaders of the Venezuelan drug cartel alleges Maduro's involvement in the drug trade was more extensive than previously thought, and he eventually became one of the top bosses of the organization.

Maduro "helped manage and, ultimately, lead the Cartel de Los Soles as he gained power in Venezuela," the indictment reads. While officially charged in the U.S. in 2020 as being one of the Venezuelan officials responsible for turning the country into a drug-trafficking state, the prevalent view has been that Maduro played a minor role in the cartel, with the leadership of the organization frequently being attributed to former National Assembly Presi-

dent Diosdado Cabello and his now disgraced rival, former Vice President Tareck El Aissami.

Maduro's name does not often appear in court documents describing the initial meetings held by Chavez with his top lieutenants as he moved to set up a partnership with the guerrilla group Revolutionary Armed Forces of Colombia, FARC, to ship cocaine to the United States.

But Maduro's influence in the cartel grew following Chavez's death as he assumed the Venezuelan presidency and as the interests of the drug-trafficking operations began to intertwine with the matters of state, court documents show.

The FARC, which eventually entered into a peace process with the Colombian government, was for many years considered one of the largest producers of cocaine in the world. The U.S. State Department placed the annual volume of the drug transiting through Venezuela at more than 250 tons. Experts believe the current volume going out of Venezuela doubles that amount.

The Venezuelan regime has two key reasons for entering the drug trade, the indictment says.

"The Cartel de Los Soles sought not only to enrich its members and enhance

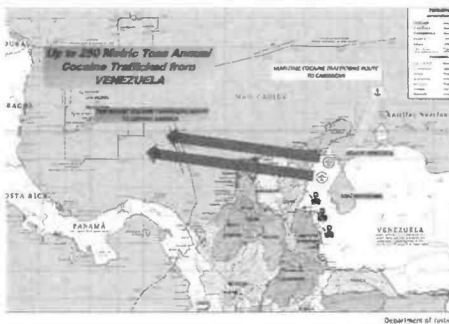
their power, but also to 'flood' the United States with cocaine and inflict the drug's harmful and addictive effects on users in this country," the document says.

The previously sealed indictment says Maduro participated in negotiations to secure multi-ton shipments of cocaine from the FARC in exchange for the delivery of money and weapons to the guerrilla group.

U.S. officials also accuse him of coordinating with the authorities of Honduras and other Central American countries for the uninterrupted passage of drug shipments heading toward the United States.

Those efforts helped set up an "air bridge" of drugs in the region. The State Department reported that 75 flights of small planes suspected of carrying drug loads were detected in Honduran airspace in 2010 alone. But flights are just one of several methods used by the cartel; a large portion is shipped by speedboats on established routes through the Caribbean.

"The maritime shipments were shipped north from Venezuela's coastline using go-fast vessels, fishing boats, and container ships. Air shipments were often dispatched from clandestine airstrips, typi-

Eventually, the cartel used the state-run Petroleos de Venezuela to launder funds from its drug-trafficking operation.

As the partnership with the FARC grew, Maduro found himself getting more involved in the operation, participating in meetings with the rebel group to get more drugs in exchange for weapons and more money. One of his roles as foreign minister under Chavez was to ensure that the border with Colombia remained open to allow shipments coming from the neighboring country to enter without disruptions.

The operation continued to grow after Maduro became president in 2013, following Chavez's death, with his family members seeking to benefit directly from the drug trade.

Maduro's nephews, raised by First Lady Cilia Flores, were arrested in 2015 in a DEA sting for attempting to export 800 kilos of cocaine to the United States. They were extradited and found guilty the following year and were sentenced to 18 years.

The nephews, who were released in 2022 as part of a prisoner swap with Venezuela, had told DEA informants during a sting operation that they had sought to obtain \$20 million to help finance Flores' election campaign to the Venezuelan National Assembly.

Their aim was political in nature, they claimed in the recorded conversations.

While describing Maduro as his father, one of the nephews said "what we want is for him to take control again of the National Assembly," which was at the time controlled by the opposition.

After the arrests, two of the DEA informants involved in the sting were murdered.
