SUBJECT: REFERRAL TO THE FINANCE AND ECONOMIC RESILIENCY COMMITTEE TO DISCUSS THE POSSIBLE EXPANSION OF THE COMPOSITION OF THE SPECIAL EVENT REVIEW COMMITTEE BEYOND MEMBERS OF THE CITY ADMINISTRATION.

RECOMMENDATION

I would like to refer a discussion to the Finance and Economic Resiliency Committee regarding the possible expansion of the composition of the Special Event Review Committee beyond members of the City Administration.

Currently, the Special Event Review Committee (the "SERC") consists of representatives from various City departments. I propose exploring the possibility of expanding and diversifying its composition to include representatives of community stakeholder organizations and relevant industries. I believe that such an inclusive approach could better promote community engagement, bring more diverse perspectives to the decision-making process, and enhance the SERC's ability to evaluate special events in a more comprehensive and holistic manner.
