WHEREAS, the City of Miami Beach's website offers a feature called "Resident Connect," which allows residents to plug in keywords of subject matters that they are interested in following at any City Commission or Commission Committee meetings, and be notified when their keywords appear on City Commission or Committee meeting agendas; and

WHEREAS, this feature provides an invaluable service to the residents by ensuring they are informed and engaged with the matters that affect the community; and

WHEREAS, the City recently transitioned its legislative agenda managing platform from Novusolutions to OneMeeting by Granicus, resulting in the temporary discontinuation of the Resident Connect functionality; and

WHEREAS, while transitioning to a new web platform requires necessary fixes, adjustments, and improvements to ensure a smooth and effective operation, the re-establishment of the Resident Connect functionality is crucial to maintain transparency and keep residents informed and engaged with City Commission activities.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby urge the Administration to re-establish the "Resident Connect" functionality in the Granicus (OneMeeting) agenda platform within an expedited timeline.
