BACKGROUND/HISTORY

ANALYSIS

LAWSUITS FILED BY OR AGAINST THE CITY OF MIAMI BEACH SINCE THE LAST REPORT:

1. **VICKI BELL V. CITY OF MIAMI BEACH, a municipal corporation located within Miami-Dade County, a political sub-division of the State of Florida, and SUPERIOR LANDSCAPING & LAWN SERVICE INC., a Florida Profit Corporation,** Circuit Court of the 11th Judicial Circuit in and for Miami-Dade County, Florida, Case No. 2024-013948-CA-22

This case arises from an alleged incident that took place on March 26, 2023, when Plaintiff was walking on the sidewalk "located at or about the northeast corner of Collins Avenue and 13th Street in Miami Beach, Miami-Dade County, Florida" and tripped and fell due to an allegedly "unsafe change in elevation." Plaintiff's two-count Complaint asserts claims for negligence against the City (Count I) and Superior Landscaping & Lawn Service (Count II). The Rogers Law Group represents the Plaintiff in this matter. The Office of the City Attorney will vigorously defend this matter.

2. **MARIANNA PICULA v. CITY OF MIAMI BEACH and FLORIDA DEPARTMENT OF TRANSPORTATION,** Circuit Court of the 11th Judicial Circuit in and for Miami-Dade County, Florida, Case No. 2024-013692-CA-15

This matter arises from an alleged incident that took place on February 22, 2023, when Plaintiff "tripped and fell on the uneven/raised portion of the sidewalk" located "along Collins Avenue (A1A), near 18th Street, Miami Beach, Florida." Plaintiff's two-count Complaint asserts claims for negligence against the City (Count I) and the Florida Department of Transportation (Count II). The Law Office of Saban and Solomon represent the Plaintiff. The Office of the City Attorney will vigorously defend this matter.
