**WHEREAS**, Visit Florida, created pursuant to § 288.1226 of the Florida Statutes, is the state's official source for travel planning, and is the premier sales and marketing organization that promotes tourism to Florida through sales, advertising, promotions, public relations and visitor services programs both domestically and internationally; and

**WHEREAS**, as the official tourism website for the State of Florida, VisitFlorida.com has included in the past a dedicated "LGBTQ Travel" section which provided valuable information on gay-friendly beaches, Pride events, and LGBTQ road trip ideas to promote the state's LGBTQ-friendly destinations, events, and attractions, thereby supporting and welcoming LGBTQ travelers and residents; and

**WHEREAS**, however, this "LGBTQ Travel" section, has been unceremoniously removed from the website at some point within the past four months, as indicated by archived versions of the site; and

**WHEREAS**, the removal of this section has caused concern among LGBTQ communities and allies, who view the deletion as a further step back from Florida's commitment to inclusivity and diversity; and

**WHEREAS**, VisitFlorida.com continues to provide travel information for other minority groups, including Black and Hispanic travelers, indicating that the removal of the "LGBTQ Travel" section is not part of a broader effort to streamline content but rather a specific exclusion of LGBTQ-related information; and

**WHEREAS**, Florida has faced broad criticism in the recent years for actions perceived as discriminatory towards the LGBTQ community, including controversial legislation and policies that have undermined LGBTQ rights and protections; and

**WHEREAS**, last year, the Human Rights Campaign, the nation's largest LGBTQ advocacy group, and the statewide LGBTQ nonprofit Equality Florida issued a travel advisory detailing the risks of traveling to the state and citing "the devastating impacts of laws that are hostile to the LGBTQ community;" and

**WHEREAS**, a recent survey of 2,300 LGBTQ Americans by the International LGBTQ+ Travel Association ("IGLTA") found that 52% of respondents indicated hesitancy or outright refusal to travel to Florida due to anti-LGBTQ legislation passed in recent years; and

**WHEREAS**, however, about 66% of respondents also said that they would be willing to visit LGBTQ-friendly cities within states that have anti-LGBTQ laws; and

**WHEREAS**, the previous "LGBTQ Travel" section played a significant role in highlighting LGBTQ-friendly cities and welcoming and inclusive destination for LGBTQ travelers, and its removal undermines this important message; and

**WHEREAS**, to remain a top state in the hospitality industry, Florida must remain committed to catering to diverse markets to secure a fair share of business from statewide, national, and international tourism.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA**, that the Mayor and City Commission hereby urge Visit Florida to promptly reinstate the "LGBTQ Travel" section on its website to continue supporting and promoting Florida as an inclusive and welcoming destination for LGBTQ travelers; and further, direct the City Clerk to transmit a copy of this Resolution to the Board of Directors of Visit Florida, and Governor Ron DeSantis; and further, direct the City Clerk to transmit a copy of this Resolution to the Greater Miami Convention and Visitors Bureau, urging them to join the City of Miami Beach in this request.
