RECOMMENDATION

BACKGROUND/HISTORY

ANALYSIS

On August 20, 2024, and at the request of the City Commission, a Countywide referendum was held to approve the construction of a new Fire Station No. 1 on Alton Road, along the west side of Flamingo Park. An overwhelming majority of Miami-Dade County voters voted in favor of the measure, with 75.71% voting in favor and 24.29% opposed. Additionally, the results for Miami Beach precincts indicate strong support from City residents, with every Miami Beach precinct voting in favor of the new location. A copy of the certified election results, including a detailed breakdown of votes per City precinct is attached.

On June 26, 2024, the City Commission adopted Resolution No. 2024-33157, authorizing the Administration to proceed with the relocation of Fire Station No. 1 to the new proposed Alton Road site (along the west side of Flamingo Park), but only if:

- The referendum is approved by a majority of Miami-Dade County voters voting in the August 20 Countywide referendum, and
- The referendum is approved by a majority of the City of Miami Beach voters, in the aggregate, voting in the referendum.

Based on the results of the referendum, I would like the City Commission to discuss, with input from the Administration, the City's next steps to implement the project at the new proposed site.


