BACKGROUND/HISTORY

Please place this item on the October 30, 2024 City Commission meeting agenda as a referral to the Finance and Economic Resiliency Committee ("FERC"). I would like the FERC to discuss a waiver of the maximum grant amount permitted under resolution 2023-32614 (i.e. \$20,000) for private property adaptation grants to fund the work necessary to raise the historic home located at 6005 Alton Road. The FERC may also wish to consider whether a general waiver of the maximum grant amount is appropriate for historic buildings eligible for a private property adaptation grant and if so, what the appropriate maximum amount should be and whether the property owner should be responsible for at least 50% of the costs as is the case for other grants pursuant to this program.
