**RECOMMENDATION**

Please include on the October 30, 2024, City Commission agenda a referral to the Land Use and Sustainability Committee to discuss adding to the Committee's agenda monthly updates on historic hotel redevelopment in Miami Beach.

On October 21, 2024, Bloomberg published an article detailing developers' ambitious plans to revitalize Collins Avenue with a \$2.5 billion investment in high-end hotels, residential units, restaurants, and more. The piece highlights a specific stretch of Collins Avenue, referred to by developers as "Billionaire Beach," encompassing the area between 14th and 20th streets. While under redevelopment, the closure of these hotels impacts surrounding businesses and also affects the city's Resort Tax collection. Additionally, it is important to note that other significant investments are underway throughout Miami Beach, further contributing to the city's development landscape.

As part of this referral, I ask that the City Administration be prepared to provide the Committee with a comprehensive overview of pending permits, including their progress and updates from the development teams on project completion. These updates will be inclusive of the specified areas of Collins Avenue mentioned above.
