TITLE: REFERRAL TO THE LAND USE AND SUSTAINABILITY COMMITTEE TO DISCUSS THE STATUS OF PRIVATE PORTION OF THE OCEAN TERRACE REDEVELOPMENT PROJECT.

RECOMMENDATION

Please place on the November 20, 2024 City Commission Agenda a referral to the Land Use and Sustainability Committee ("LUSC") to discuss the status of the private portion of the Ocean Terrace redevelopment project (the "Private Project").

BACKGROUND/HISTORY

Since 2015, there has been a plan to redevelop Ocean Terrace in North Beach. While the initial proposal for redevelopment was rejected, the developers worked collaboratively with the community to revise the Private Project and arrive at a vision that was more widely accepted. The revised plan for the Private Project, approved in 2021, includes new hotel and condo properties, while preserving several historic facades along Ocean Terrace. As part of the overall project, the city also approved the vacation of a city street to allow the developers to create a public amenity (the "Public Project") designed by Raymond Jungles, which is nearing completion.

However, in the years since the approval of the latest version of the Private Project, there has been limited movement or communication regarding its progress. Rumors have been circulating about potential changes in the Private Project's configuration, and questions remain about what the final development will look like and what timeline we can expect for its completion.

ANALYSIS

I would like to refer this item to the **Land Use and Sustainability Committee (LUSC)** to request an update from City staff and, if possible, the developer. The update should include:

1. The current status of the Ocean Terrace redevelopment project, including both the Public Project and the Private Project.
2. Any proposed changes to the Private Project's design or configuration since the 2021 approval.
3. The anticipated timeline for substantial completion of the Public Project and for commencement of construction and completion of the Private Project.
4. Any other relevant information or developments that the developer or City staff may wish to share regarding the project.

The Administration should coordinate with the developer to ensure a comprehensive update can be provided. It would be idea for a representative of the developer to be present at the LUSC meeting at which this item is heard.
