In 2021, the City issued Request for Qualifications (RFQ) No. 2021-136-WG for State Legislative Consulting Services, with the intent of retaining a state lobbyist to represent the City's interests at the state level. On October 29, 2021, the City and Ronald L. Book, P.A. ("State Lobbyist") entered into a Professional Services Agreement (the "Agreement") for State Legislative Consulting Services, with an initial term of two (2) years, and the option for two (2) additional one (1) year renewals, to be exercised at the sole discretion of the City Manager.

I would like to initiate a discussion with my colleagues to explore all available alternatives to the City pursuant to the terms of the Agreement, including, but not limited to, the potential amendment of the Agreement to place restrictions on lobbying activities before the City during the duration of the State legislative session.
