**1. OUTFRONT MEDIA GROUP, LLC. V. THE CITY OF MIAMI BEACH, FLORIDA AND IKE SMART CITY, LLC**

Case No. 2024-021168-CA-22 (Circuit Court of the 11<sup>th</sup> Judicial Circuit in and for Miami-Dade County, FL)

This is a one-count Complaint for Expedited Declaratory Relief filed by Plaintiff Outfront Media Group LLC (which has a contract with the City of Miami Beach regarding advertisements on bus shelters) challenging the legality of the City's contract with co-defendant IKE Smart City LLC (which has a contract with the City of Miami Beach regarding interactive digital media kiosks to be installed in certain rights-of-way). The Office of the City Attorney will vigorously defend this matter.
