### **BOARD AND COMMITTEES:**

#### **1. AD HOC CITY LIGHTING PLAN ADVISORY COMMITTEE**

*VACANCIES (3):*

- One South Beach resident.
- Two North Beach residents.

#### **2. AD HOC CITY SANITATION ADVISORY COMMITTEE**

*VACANCIES (4):*

- Resides within the jurisdiction of the local governing body making the appointments. (Category # 9)
- Represents employers within the jurisdiction. (Category # 10)
- Represents essential services personnel, as defined in the local housing assistance plan. (Category # 11)

*Five true vacancies and one vacancy to replace term-limited member Barbara Montero (Category # 9).*
