RECOMMENDATION

BACKGROUND/HISTORY

Please place on the November 20, 2024 agenda a referral to the Finance and Economic Resiliency Committee (the "Committee") to consider outdoor dining concession fee reductions during the summer months and the abatement of outdoor dining concession fees during the first three months of operation for new establishments.

As we continue to support the vibrancy and economic recovery of Miami Beach's hospitality and restaurant sectors, I would like to discuss potential adjustments to outdoor dining concession fees in recognition of the challenges faced by both existing and new businesses with my colleagues.

DISCUSSION:

Fifty Percent Reduction in Concession Fees for Existing Concessionaires (August, September, October):

During the traditionally slower summer months, specifically August, September, and October, I propose a 50% reduction in the outdoor dining concession fees for existing concessionaires. These months are typically marked by a downturn in business activity due to seasonal factors, including the hot summer weather and a decrease in tourist visits. By reducing the fees, we can provide financial relief to existing concessionaires, helping them to navigate these challenging months while maintaining their operations. This reduction will support the resilience of our local businesses and help them retain staff during an otherwise difficult period.

Fee Abatement for New Establishments (First Three Months of Operation):

Additionally, I propose the implementation of a fee abatement for new establishments for the first three months of their operation. This temporary abatement would allow new businesses to establish themselves without the added financial burden of full outdoor dining concession fees. The goal is to give new establishments a stronger chance to prosper and attract customers, which in turn will contribute to the overall economic health of the neighborhood and the City.

The Administration should be prepared to discuss the fiscal impact of the above proposals at Committee.
