WHEREAS, the City of Miami Beach is committed to supporting its workforce, particularly those who play vital roles in public service; and

WHEREAS, the aides to the Mayor and City Commissioners are critical members of the staff who provide invaluable support in the performance of City business, often working demanding schedules that require in-person commitments during unpredictable hours, late nights, weekends, and holidays; and

WHEREAS, the high cost of housing in the City of Miami Beach, coupled with the limited availability of workforce and attainable housing options, presents a significant challenge to retaining qualified and dedicated individuals in positions that require regular in-person presence and performance; and

WHEREAS, the current wage structure for City Commissioner aides does not adequately align with the high cost of living in the City, which further exacerbates the housing challenges faced by these essential staff members; and

WHEREAS, in light of these challenges, it is necessary to provide reasonable assistance to City Commissioner aides to help them secure suitable housing within the City of Miami Beach, thereby ensuring that they are able to maintain their professional responsibilities and remain in close proximity to their workplace; and

WHEREAS, the Mayor and City Commission recognize the need to implement such a stipend program and to identify funding sources for the same.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby authorize a stipend in the amount of \$500 per month for each City Commissioner aide to enable these critical members of the staff to find suitable housing in the City of Miami Beach; and further, direct the Administration to identify funding within the FY 2025 budget for this purpose.
