BACKGROUND/HISTORY

Our current building permit review process is challenging to the point that it frustrates people into reaching out to the elected leadership of the City to help navigate the process. The frustration has led to multiple initiatives trying to find ways to improve the process.

ANALYSIS

From "The Get Go" initiative aims to overhaul the building permit review process by ensuring that ALL necessary items are identified by City personnel during the initial submission and review. This initiative seeks to enhance efficiency, accountability, and clarity, ensuring that the permit process is expedient and predictable for applicants.
